Amendment 003 is raised to respond to questions raised after the release of the Solicitation and to update the Basis of Payment.

1. **Annex “B” Basis of Payment – Items 1, 2, 3 and 4 “Per-Call and Hourly Rates”:**
Are related expenses such as travel cost, disbursements, accommodation included in the “Call-Up” and “Hourly Rate”?

A: Refer to Basis of Payment attached.
2. **Annex “B” Basis of Payment – Items 5, 6, 7 and 8 “Consumable Cost Per Sample”:**
What Turn Around Time (TAT) for receipt of laboratory results is expected to be used in calculating per sample costs?

A: Turnaround Time is 2 days.
3. Annex B Basis of Payment tables request a price per call for both during regular working hours, and outside of regular working hours. The tables indicate the call-ups include travel, first hour on-site of productive labour to conduct sampling, **sample analysis**, inspection, report preparation, consulting and project meeting.
What type of analysis are we to include in the per call cost? Or, are we not to include the analysis cost in the per call cost, as that would be covered under the consumables section?

4. Annex B, Basis of Payment, bidders are to submit firm prices/rates for ALL items in Annex B. My concern/question is specifically to line items 1 and 2 of the Basis of Payment Annex B, the “Per Call” cost. Annex B indicates the Call-Ups are to include (Travel, First Hour of On-Site Productive Labour, Sample Analysis, Inspection, Report Preparation, Consulting and Project Meeting). My question is:
The bidder has no idea the magnitude of each call up, scope of work, how many samples, what kind of sample, what deliverable is needed (full report, technical memo, analytical results), etc. If you could give more description to what is expected for a typical “Per Call” project would be helpful.

Annex A, Statement of Work section 3.3 indicates 12 different work descriptions all that would have variable cost on a “Per Call” basis.

A. Call-Ups are created on a “*as and when requested*” need. There isn’t any way of determining in advance of what will be required or when.
