THE FOLLOWING AMENDMENT TO THE TENDER DOCUMENTS IS EFFECTIVE IMMEDIATELY. THE AMENDMENT SHALL FORM A PART OF THE CONTRACT DOCUMENTS.

1. Questions and Answers:

 Question 1:
 Location of the old stuart st (where the road base granulars still exist)

 Answer 1:
 I believe they mean "Old Byron Street". Old Byron street is located where the existing bike path is located.

 See attached Drawing A-8

- Question 2: Areas where construction vehicles may access the site (bike trail, etc)
- Answer 2: Please see attached Drawing A-8 for access roads

Question 3: That work would be stopped if a rut 6" or deeper is caused by construction, causing an archaeological assessment. Can you please expand on the details of this assessment, and what costs the contractor would be responsible for?

- Answer 3: Contractor is to ensure that ruts caused by the work do not exceed 6". If rutting occurs during the work, contractor is to take whatever precautions necessary to protect the grounds from any further rutting. If rutting occurs at 6" or greater, then project manager should be notified and corrective measures taken. If due to the assessment, archeological intervention is required, the contractor will be responsible to secure an archeologist to examine the area of damage greater than 6" or as defined by Project Manager and will be supplied with a statement of work from Parks Canada Agency Terrestrial Archeology. Contractors are always encouraged to maintain an acceptable level of turf damage in their work area and to take whatever measures may be required to avoid this condition.
- Question 4:The embedded pickets are required to be 10.65 feet, is it okay if they are only 10 ft long?Answer 4:Yes acceptable, as long as the pickets are still 1.2 meters in ground.
- **Question 5:** The material calls for red pine for the pickets, would cedar and/or spruce pine be acceptable alternates?
- **Answer 5:** For the purpose of this competitive process, contractors are to bid on the materials in the specification.
- **Question 6:** Do the tips of the pickets need to be rounded to a point or can the points be a little square?
- **Answer 6:** The pickets are to be rounded to a point to match existing.

By submission of its tender, the Tenderer confirms that it has read and understands the requirements expressed in all addenda and has included all costs of these requirements in its Total Tender Amount.
