**Add the following clause in Part 7 – Standing Offer and Resulting Contract Clauses, Section A. Standing Offer, paragraph 7A.4 – Term of Standing Offer:**

**7A.4.3 Basis of payment, second and third years and extension of the term of the Standing Offer**

1. For the second and third years as well as the extension year, the same terms and conditions as stipulated in the original Standing Offer applies, except that:
  - 1.1 All unit prices as shown in the Standing Offer or as amended pursuant to the terms and conditions as expressed herein shall be increased or decreased by the percentage change in the Energy Price Index as published by Statistics Canada for the area of Canada in which the goods are being provided calculated for the first 12 months of the 14-month period immediately preceding April 1<sup>st</sup> of each respective year of the Standing Offer.
