Part A) Questions and answers

Question 1: Related to Part 4 – Evaluation procedures and basis of selection, under 4.1.1.1 Mandatory Technical Criteria – M1 Video production samples:

The question is related to the video samples that we are planning to include with our proposal. Can we provide samples of videos contained in three (3) of our web based educational programs, but rather than feature a single full length, (or almost full length) video, we would be providing short clips (one (1) minute +-) from a variety of videos in each of the three (3) samples.

For example, we produced education web site that contains a hundred or so videos with a variety of running lengths in both French and English. Our sample of that work will include three (3) or four (4) videos, one full length and a portions of a few others running at a minute or so each. This will not be a montage, but a collection of portions of a few of the videos. We will provide a similar collection for each of the three (3) samples and will respect your total running time not to exceed fifteen (15) minutes.

Answer 1: The Bidder can choose the length of each video production samples in response to M1. However, the combined running time of the video production samples must not exceed fifteen (15) minutes and must meet all other elements found in the criteria.
