Amendment 001 has been issued to provide additional information on the Industry Day, remove Annex C, Engagement Rules, and include the Excel Attachment as referenced in Section 3.4 PSPC Food Evaluation Tool and National Evaluation Method

Industry Day Questions:

Question 1 – As a supplier, we are interested in attending the Industry Day and One-on-one meetings, can you provide some additional information on what we can expect?

Answer 1 – The Industry Day will be an opportunity to hear from the Department of National Defence, Correctional Services of Canada and the Department of Fisheries and Oceans which are the three major departments that purchase food across the federal government.

Public Services and Procurement Canada (PSPC) encourages all interested suppliers to attend the Industry Day to learn more about how each department purchases food and beverages to meet their operational requirements. While PSPC understands that attending in-person may be difficult for some suppliers, there will be an opportunity for suppliers to participate online via WebEx.

Question 2 – I would like to participate in the Industry Day and One-one-one meetings but due to my location, cannot come to Toronto for February 27. Is there any other way to participate?

Answer 2 – Yes, PSPC will be hosting a WebEx session for the Industry Day and One-on-one meetings to allow participation of all interested suppliers. The Industry Day will be held from 1-3PM EST on February 27, 2018 at PSPC's Regional Headquarters 4900 Yonge Street Toronto, ON M2N 6A6. To participate via WebEx, suppliers must contact the Contracting Authority, Jeff Schmidt, to request the WebEx link and to provide a list of participants. Only those suppliers who sign-up will be provided the WebEx invitation.

One-on-one meetings will be held in-person or via WebEx at PSPC's Regional Headquarters following the Industry Day. PSPC will work with suppliers and client departments to identify a mutually agreeable time to set-up the one-on-one meetings.

Note: Please note the following change to Section 6.3 Information Prior to Industry Day

Suppliers may provide comments, questions or proposed topics for discussion for the Industry Day or one-on-one meetings by submitting their information to the Contracting Authority no later than **8 am EST (Eastern Standard Time) February 23, 2018.**

Question 3 – Do I need to provide Annex C, Engagement Rules if I only plan on attending the Industry Day?

Answer 3 – Annex C, Engagement Rules has been removed from the Request for Information and is no longer required to participate in the Industry Day or the One-on-one sessions. All information discussed during the One-on-one sessions will remain confidential.
