2. Replace 4.0 Tasks in ANNEX C – STATEMENT OF WORK.

Delete: **4.0 Tasks in ANNEX C – STATEMENT OF WORK** in its entirety; and

Insert: The following, new **4.0 Tasks in ANNEX C – STATEMENT OF WORK.**

The tasks the Contractor must perform include but are not limited to:

1. Application of required plumbing / mechanical Permits and submission of all required certifications;
2. Perform the installation of approximately 110 CORCAN supplied combi-unit cell toilets;
3. Perform the installation of approximately 2 CORCAN supplied cell toilets;
4. Perform the installation of approximately 2 CORCAN supplied cell sinks;
5. Supply and perform the installation of the required fixtures and drains for approximately 4 showers;
6. Supply and perform the installation of approximately 1 black flow preventer to the main water supply of Range E;
7. Supply and perform the installation of the required fixtures/ drains/ etc. for approximately 4 laundry areas;
8. Supply and perform the installation of all the existing copper Cold, Hot and Recirculating water line replacement on "E" range which must be replaced with a type "L" copper pipe and new valves. This includes 15 2-inch supply lines feeding the 4 story E block cells. Each line feeds 8 cells, and will require an isolation valve at each cell, so each cell can be shut off without disturbing the whole range. The Contractor must also effect the removal of the existing piping, concurrently.
9. Perform all other required plumbing / mechanical repairs and installations as requested and authorized by the Project Authority;
10. Upon completion of the work, the Contractor must provide a written confirmation under stamp of a Professional Engineer licenced in the Province of Saskatchewan which confirms that all work performed by the Contractor has been inspected and is complaint with the National Building Code as well as all applicable Provincial building code(s). The most stringent requirements must take precedence;
11. The Contractor may be required to assist in the Mandate by working with Offenders; and
12. The Contractor must clean the work area and any other space that has been affected by their activity

ALL OTHER TERMS AND CONDITIONS REMAIN UNCHANGED.
