1. Questions and Answers

Question 1

As part of the invitation EN966-140305/I, you enter new fields on page 19.

Do you mean that you have subdivided technical fields?

I have a SA for Tier 1 in Mechanics and Transportation. Can I expand my current SA and add subfields to the final RFSA, still for Tier 1?

Answer 1

Yes, some fields have been subdivided.

A supplier who is currently qualified for a field that has been subdivided will be automatically qualified for each subfield unless they request for qualification for only one or more of the subfields.

Notice will be sent to suppliers by the Supply Arrangement Authority to confirm their choice.

2. Consultation Session

The Translation Bureau and Public Services and Procurement Canada (PSPC) will hold a consultation session to solicit supplier's comments and recommendations on the draft Request for Supply Arrangement (RFSA) and the draft bid solicitation template.

Suppliers' participation in the consultation session is voluntary. Canada will not cover any costs or expenses incurred by suppliers in connection with participation in the consultation session.
