Requirement Summary

The Government of Canada will host the meeting of Group of Seven (G7) June 8-9, 2018. The Summit will be held at the Fairmont Le Manoir Richelieu in La Malbaie, Quebec, located in the Charlevoix region.

The Summit Management Office (SMO) and the Royal Canadian Mounted Police (RCMP) requires the services of suppliers who can ensure the ground transportation of G7 participants and personnel associated with the Summit. This includes daily transportation between accommodation and work sites within the greater geographical regions of Quebec City, Saguenay, Tadoussac, Charlevoix and elsewhere in the province of Quebec, New Brunswick.

Transportation services will be required between April 01, 2018 and June 29, 2018, inclusively.

Objective of Industry Consultation

- The SMO will provide an overview of the requirement and additional information regarding the types, volume and frequency of transportation vehicles required.
- Determine the capacity of the Industry to meet the transportation requirements of the summit
- Public Services and Procurement Canada (PSPC) will outline the proposed procurement approach to acquire the required transportation services.
