### **QUESTIONS AND ANSWERS**

#### **Question 1:**

Is it just the sample fabric to be purchased for the RCMP or all fabric? Can I see a sample?

#### **Answer 1:**

The Government Available Material identified at Article 6.18 is required for the Pre-Contract Award Sample, the Pre-Production Sample, the Production Sample (if required), the full production of the firm quantity, the full production of the "as and when requested" flexible stock and the full production of the "as and when requested" specials. As per Article 4.1.1.1, a RCMP viewing sample will be provided to Bidders who are requested to provide Pre-Contract Award Sample.

#### **Question 2:**

Are potential bidders only required to submit a technical and financial proposal by the bid closing date, and await instruction to provide certificate of compliance and pre-contract award sample?

#### **Answer 2:**

As per Article 3.1, Bidders must submit their Technical Bid, their Financial Bid (Annex A) and their Certifications (Part 5). In their Technical Bid, Bidders are to complete the required sections of Part 6. As per Article 4.1.1.3 Pre-Contract Award Sample and Certificates of Compliance will be required after the bid closing date, upon a written request from the Contracting Authority.

#### **Question 3:**

Would we be able to see the viewing sample prior to placing a bid?

#### **Answer 3:**
