### **AMENDMENT 005**

The purpose of the amendment is to answer bidders' questions received in response to this RFP.

#### **Questions and Answers:**

***Q10: In Annex C, R3 and R4: Can the Survey Manager also be one of the Senior Researchers? How would this affect the point scoring for the Survey Manager or the Senior Researcher?***

**R10:** The Survey Manager cannot be the same person as the Senior Researcher, given the scope of the project and the large amount of work that will be required to conduct this project. However, the Bidder is not required to provide more than one Senior Researcher.

***Q11: Due to an unexpected personal emergency experienced by a key team member, we would like to respectfully ask for a one week extension on the submission deadline for this proposal.***

**R11:** Due to operational requirements, Canada will not grant an extension to the closing date at this time. The timelines for this project are extremely tight, and a one-week extension would compromise our ability to conduct the project as per the planned schedule.
