For example, using the same person for the Project Manager role and the Scheduler role as the Scheduler role typically falls under the Project Manager's scope and qualifications.	A team member can fulfill more than one roll of the requested Construction Management Team with the exception that the Site Superintendent can not be same as the Project Manager. If a proposed team member is fulfilling more than one role then it must be clearly demonstrated in the proposal, and the proposed resource's experience clearly demonstrated under each role.
