## **A. Questions and Answers**

### **Question 1:**

Reference: Annex A, Section 1. "SHELTER REQUIREMENTS" paragraph (b)  
Concerning Space for Desk / Table for eating, working and meeting.  
Do we have to provide the Desk/Table?

Reference: Annex A, Fig. 1  
In the sketch we see mentions of Counter, Storage and Bunk Beds.  
Do we have to provide the solutions for the counter, storage and bunk beds?

### **Answer 2:**

### **Question 3:**

Reference: Annex A, section 1.2 "National Building Code 2015"  
We note that the requirement 1.2 (b) appears to refer to Part 3 of the National Building Code (NBC) and that some of the requirements included in 1.2 (a) to (i) appear to be restatements of the NBC (for example 1.2(a)) while others appear to be modifications to the NBC (for example 1.2 (f)).

Therefore we submit that it is unclear from the wording of 1.2 whether the mandatory requirements which the shelters must meet are limited to the explicit requirements of 1.2 (a) – (i), or whether they extend further to include the requirements of all of Part 9 of the NBC or whether they extend even further to the entire NBC

Given the mandatory nature of the requirements outlined above, we submit that it will be necessary for all Bidders to understand precisely what those requirements are in order to have a reasonable and fair opportunity to deliver a compliant bid.

We therefore request clarification on the requirements of 1.2.

**Answer 3:**

*The shelter is to meet the requirements of division B part 9 of the NBC based on its intended use and occupancy. However, NBC division B part 9 refers to other section of the code that may need to be met. The exception is the accessibility section 3.8.2.1 where it is indicated that due to the intended use of the shelter, a barrier free design is not required. If the future intended use is to make the shelter barrier free, it is Parks Canada's responsibility to ensure its compliance to the NBC. The drawing provided are samples of the intended use and occupancy of the shelter. It provides to the supplier an indication which sections of the Code would be relevant and applicable.*

*Section 1.2 is intended to highlight the key points of NBC division B part 9 without the necessity to write the Code in its entirety since many parts of the code are not relevant due to the intended use and occupancy. If in the future Parks Canada chooses to modify the intended use and occupancy of the building from what is shown, then it is the responsibility of Parks Canada to ensure compliance with NBC.*

*Section 1.2f does not quote section 9.10.10.4 of the Code in its entirety. However exceptions to the fire separation and fire resistance rating are permitted in section 9.10.10.4.2 and 9.10.10.4.3. Based on the exceptions of 9.10.10.4.2 and 9.10.10.4.3 and intended use and occupancy of the space, it can be concluded that no fire separation is required for fuel fired appliances.*
