QUESTIONS AND ANSWERS:

Q1.

With reference to:

Proposal Document - Page 30 of 96 - Consultant / Key Specialist: Project Manager - Architect, Conservation Specialist

When you say "with at least seven (7) years of full-time experience in conservation of historic masonry buildings", does this mean that the architect in charge of the project must have done only conservation of historic buildings in masonry work for 7 years and must not have participated in any other type of architectural project?

R1. See addendum 1, attached.

Q2. A)

In item **3.2.2 Experience of mandatory members (40 points)** _ **APPENDIX** « **F** » For the Proponent (Senior Consultant): Senior Architect Project Leader, the 9 projects to be submitted in Appendix F do not necessarily have a link to the Annex G projects?

R2. A. In the case of the Senior Architect Project Leader, the 9 projects that have to be present in the table "ACHIEVEMENTS - PROFESSIONAL EXPERIENCE" in the Annex F does not relate to projects in Appendix G, because no project is required in Appendix G for the Senior Architect Project Leader. Nevertheless the Senior Architect Project Leader is free to present in the table "ACHIEVEMENTS - PROFESSIONAL EXPERIENCE" in Annex F one of the nine projects (PROJECTS 1 to 9) if the Senior Architect Project Leader has worked with one of the Consultants / Key Specialists that summit one of these projects.

Q2. B)

Item 3.2.2 Experience of mandatory members (40 points) _ APPENDIX « F »

For the Consultant / Key Specialist: Project Manager - Architect, Conservation Specialist, of its 6 projects to be presented in Appendix F, 3 will projects 1,2,3 presented in Appendix G? And so on for the other key members of the 9 projects in Appendix G.?

R2.B)

Yes. PROJECTS 1, 2 and 3 of Annex G which concern the Project Manager - Architect, Conservation Specialist must be included in the table "ACHIEVEMENTS - PROFESSIONAL EXPERIENCE" in Annex F. If the bidder does not submit PROJECT 3, only PROJECT 1 PROJECT 2 will be part of the table. This standard applies to other key members. (See proposal document - Page 30 of 96 -. 3.2.2 b) last paragraph of point b)).

Q2. C)

Item 3.2.2 Experience of mandatory members (40 points) _ APPENDIX « F »

Can we present the same projects in architecture, structure, mechanics and electricity, if all the consultants have worked on the same projects and should we repeat them? Or do we have to present separate projects for each key specialist?







R1. C)

The team of experts may present the same projects in architectural, structural, mechanical and electrical (ANNEX G) if the members of the team of experts have participated. It is not necessary to fill the contents of the project sheet again, but it is required to submit the project sheet without filling in but indicating only in the sheet, the project title and the number of the project (Project No.) that meets the requirements of this project. In this case, in the project description, it must mention the members of the expert team involved.

Q2. D)

In item **3.2.2 Experience of mandatory members (40 points)** _ **APPENDIX** « **F** » for specialist c), d) and e) we believe that an error was made in reference to Appendix 3, which should be Annex G instead? Thank you for confirming.

R2.D)

Yes, it is an error, the correct reference is Appendix G. See Amendment 2.

Q3. The analysis of the condition of the party walls is part of the scope of the work?

R3. Yes

Q4.

In the form of the rehabilitation of the Louis-Joseph-Papineau National Historic Site, it is permitted for the presentation of the firm of the section Presentation of the proposer a text of 500 words only. It seems to us impossible to properly present our firm, as well as those of other consultants in just 500 words. This limited number of words does not allow us to explain the relationship of the partnerships, the expertise, the particularities, the capacity and the way of providing the required services, the continuous control and the efficiency for each of the three firms of the experts. This is why we would like the maximum number of words in this section to be increased to 1000 words.

Q5. Could a one-week extension of the call for tenders be considered?

Can the Conservation Architect Project Manager be a consultant (subcontractor) to the proposed architect firm?

R6. Yes it is acceptable, the proponent can model its expert team as long as it meets the requested criteria.

Amendment 1

- . 1 In all documents concerning the experience of the team of experts
- . 2 "Years of full-time experience" or "years' experience" or "full years' full-time experience" or "years of experience" or "years completed with full time experience" or "years of full time practical experience" means an appreciable experience and an scope would normally vest over a period of at least ten (10), seven (7) or five (5) years, according to each case, carried out over the twenty (20) years in the task (for example the preservation of historic masonry buildings). During these years of experience, expert consulting s may have worked in other types of projects non-attached to defined projects, an exclusive practice is therefore not required. In addition, years of experience may not have been developed continuously.

Amendment 2

In the French version only, in the document "request for proposals» in the item "3.2.2 Experience of mandatory members (40 points) _ APPENDIX « F »" please replace all references to Appendix 3 to Appendix G.

Amendment 3

In the document "request for proposals" in the point " 3.2.1 Proponent presentation (10 points) - APPENDIX « E » " at the point "1. Presentation of the firm" on Page 29 of - de 95, replace "a text of maximum 500 words" by "a text of maximum 1000 words".

In the document " request for proposals in "APPENDIX E – PROPONANT IDENTIFICATION FORM " at the point "1- Presentation of the firm (8 POINTS)" Page **39** of - de **95**, replace " Text 500 words maximum " by "Text 1000 words maximum".

In Annex E, if the proposals need an extra sheet will be inserted one page more in the sheet, please use the Page 40 of - de 95 twice as sheet supplementary.

Amendment 4

- 1 In all documents concerning the projects on the board ACHIEVEMENTS PROFESSIONAL EXPERIENCE in ANNEX "F" and the projects in APPENDIX G ACHIEVEMENTS OF THE TEAM EXPERT.
- .2 "Project" means:
- a. A construction project where construction work has been done and completed, so final certificate of completion had to be emitted. For this projects where a value of work is required, the value of work completed must meet the requirements indicated for the total dollar value of the project. For this projects where a type of construction is required, for example, the restoration of traditional stone masonry walls (unarmed), completed work must meet the stated requirements. OR
- b. A construction project where all the works have been done and completed except for the deficiencies and the client has taken possession of the works, so a certificate of substantial completion of the work had to be emitted. For this projects where a value of work is required, the value of work completed must meet 95% of the total dollar value of the project. For this projects where a type of construction is required, for example, the restoration of traditional stone masonry walls (unarmed), completed work must meet the stated requirements.







There is no change to the bid closing date.
