Question 1:

Are the 1 page resumes for bridge inspectors required by SRE 3.2.3 included in the page count? The second bullet of SRE 2.2 has the phrase "Does not include resumes" but the intent of this phrase is not clear.

Answer 1:

All Resumes are included in the page count

Question 2:

PR 1.6 states that 100% complete tender documents are to be complete by March 31 of 2018 but it appears that the inspections were originally predicted to take place in the fall of 2017. Is there a revised schedule?

Answer 2:

The start of the project has been delayed, so with an expected award date of March 15, 2018, the revised due date is June 30, 2018.

Question 3:

Have the latest comprehensive detailed inspections (awarded to SNC in fall of 2017) been completed and, if so, will the inspection reports be available to the successful proponent?

Answer 3:

The 2017 inspection report will be submitted March 31, 2018 and will be made available to the successful proponent.

Question 4:

- 1) Regarding the second page of the price proposal form (i.e. list of staff and hourly rates):
 - a. Will this be evaluated and, if so, how?

Answer:
