Solicitation Amendment No. 001

This amendment is raised to answer Bidders' questions:

Q1: I would like to better understand the requested products in this RFP:

- P600360.001 ComPact Ear for 19" rack Kit
 - This kit consists of: 2 x P270017 Ear for 19" rack
- P600360.002 ComPact Connecting bracket Kit
 - This kit consists of:
 - 8 x P270079 (screws)
 - 1 x P270044 Connecting bracket, front
 - 1 x P270045 Connecting bracket, back

DND requires 55 each of P600360.001 and 55 each P600360.002, but without P270079 (screws) and P270044 (Connecting bracket, front). Can you please confirm whether DND requires the full kit (P600360.002) or just the back bracket P270045?

A1: For kit P600360.002, DND only requires 110 of the back bracket P270045, not the full kit; There is no requirement for P270079 (screws) and P270044 (Connecting bracket, front).

As for P600360.001, DND requires 55 x full kit (=110 X P270017 ComPact Ear for 19" rack).

ALL OTHER TERMS AND CONDITIONS REMAIN UNCHANGED.
