This bid solicitation cancels and supersedes previous bid solicitation number HT434-172891/A dated 2018-01-31 with a closing of 2018-02-28 at 2:00pm.

PART 1 - GENERAL INFORMATION

1.1 Introduction

The bid solicitation is divided into seven parts plus attachments and annexes, as follows:

- Part 1 General Information: provides a general description of the requirement;
- Part 2 Bidder Instructions: provides the instructions, clauses and conditions applicable to the bid solicitation;
- Part 3 Bid Preparation Instructions: provides Bidders with instructions on how to prepare their bid;
- Part 4 Evaluation Procedures and Basis of Selection: indicates how the evaluation will be conducted, the evaluation criteria that must be addressed in the bid, and the basis of selection;
- Part 5 Certifications and Additional Information: includes the certifications and additional information to be provided;
- Part 6 Security Requirements: includes specific requirements that must be addressed by Bidders; and
- Part 7 Resulting Contract Clauses: includes the clauses and conditions that will apply to any resulting contract.

The Annexes include the Statement of Work, the Basis of Payment, the Security Requirements Checklist, the Electronic Payment Instruments, the Federal Contractors Program for Employment Equity - Certification, the Insurance Requirements, the Task Authorization Form 572 and any other annexes.

1.2 Summary

Health Canada, First Nations and Inuit Health Branch, Edmonton, Alberta, has a requirement for timely and reliable ground transportation services for Referred First Nations and eligible Inuit clients and approved Authorized Escorts from all over Alberta who travel to the Edmonton and surrounding areas for medical treatment. The requirement is for 24 hours a day, 7 days a week, 365 days per year, ground transportation services, including all labour, transportation, supervision, materials, maintenance, tools and equipment necessary.

This bid solicitation is to establish a contract with task authorizations. The period of the contract is September 1, 2018 to August 31, 2021 inclusive with Canada retaining the irrevocable option to extend the term of the Contract by up to two (2) additional one (1) year period(s) under the same conditions.

There are security requirements associated with this requirement. For additional information, consult Part 6 - Security Requirements, and Part 7 - Resulting Contract Clauses. For more information on personnel and organization security screening or security clauses, Bidders should refer to the Contract Security Program of Public Works and Government Services Canada (<http://www.tpsgc-pwgsc.gc.ca/esc-src/introduction-eng.html>) website.

This procurement is set aside under the federal government Procurement Strategy for Aboriginal Business. For more information on Aboriginal business requirements of the Set-aside Program for Aboriginal Business, refer to [Annex 9.4](#) of the Supply Manual.

This procurement is set aside from the international trade agreements under the provision each has for measures with respect to Aboriginal peoples or for set-asides for small and minority businesses.

Further to Article 800 of the Canadian Free Trade Agreement (CFTA), CFTA does not apply to this procurement.

The Federal Contractors Program (FCP) for employment equity applies to this procurement; refer to Part 5 – Certifications and Additional Information, Part 7 - Resulting Contract Clauses and the annex titled Federal Contractors Program for Employment Equity – Certification.

The Phased Bid Compliance Process applies to this requirement.

1.3 Debriefings

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days from receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

PART 2 - BIDDER INSTRUCTIONS

2.1 Standard Instructions, Clauses and Conditions

All instructions, clauses and conditions identified in the bid solicitation by number, date and title are set out in the [Standard Acquisition Clauses and Conditions Manual](https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual) (https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual) issued by Public Works and Government Services Canada.

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract.

The [2003](#) (2017-04-27) Standard Instructions - Goods or Services - Competitive Requirements, are incorporated by reference into and form part of the bid solicitation.

Subsection 5.4 of [2003](#), Standard Instructions - Goods or Services - Competitive Requirements, is amended as follows:

Delete: 60 days

Insert: 180 days

2.2 Submission of Bids

Bids must be submitted only to Public Works and Government Services Canada (PWGSC) Bid Receiving Unit by the date, time and place indicated on page 1 of the bid solicitation.

2.3 Former Public Servant

Contracts awarded to former public servants (FPS) in receipt of a pension or of a lump sum payment must bear the closest public scrutiny, and reflect fairness in the spending of public funds. In order to comply with Treasury Board policies and directives on contracts awarded to FPSs, bidders must provide the information required below before contract award. If the answer to the questions and, as applicable the information required have not been received by the time the evaluation of bids is completed, Canada will inform the Bidder of a time frame within which to provide the information. Failure to comply with Canada's request and meet the requirement within the prescribed time frame will render the bid non-responsive.

Definitions

For the purposes of this clause, "former public servant" is any former member of a department as defined in the *Financial Administration Act*, R.S., 1985, c. F-11, a former member of the Canadian Armed Forces or a former member of the Royal Canadian Mounted Police. A former public servant may be:

- a. an individual;
- b. an individual who has incorporated;
- c. a partnership made of former public servants; or
- d. a sole proprietorship or entity where the affected individual has a controlling or major interest in the entity.

"lump sum payment period" means the period measured in weeks of salary, for which payment has been made to facilitate the transition to retirement or to other employment as a result of the implementation of various programs to reduce the size of the Public Service. The lump sum payment period does not include the period of severance pay, which is measured in a like manner.

"pension" means a pension or annual allowance paid under the *Public Service Superannuation Act* (PSSA), R.S., 1985, c. P-36, and any increases paid pursuant to the *Supplementary Retirement Benefits Act*, R.S., 1985, c. S-24 as it affects the PSSA. It does not include pensions payable pursuant to the *Canadian Forces Superannuation Act*, R.S., 1985, c. C-17, the *Defence Services Pension Continuation Act*, 1970, c. D-3, the *Royal Canadian Mounted Police Pension Continuation Act*, 1970, c. R-10, and the *Royal Canadian Mounted Police Superannuation Act*, R.S., 1985, c. R-11, the *Members of Parliament Retiring Allowances Act*, R.S. 1985, c. M-5, and that portion of pension payable to the *Canada Pension Plan Act*, R.S., 1985, c. C-8.

Former Public Servant in Receipt of a Pension

As per the above definitions, is the Bidder a FPS in receipt of a pension? **Yes** () **No** ()

If so, the Bidder must provide the following information, for all FPSs in receipt of a pension, as applicable:

- a. name of former public servant;
- b. date of termination of employment or retirement from the Public Service.

By providing this information, Bidders agree that the successful Bidder's status, with respect to being a former public servant in receipt of a pension, will be reported on departmental websites as part of the published proactive disclosure reports in accordance with Contracting Policy Notice: 2012-2 and the Guidelines on the Proactive Disclosure of Contracts.

Work Force Adjustment Directive

Is the Bidder a FPS who received a lump sum payment pursuant to the terms of the Work Force Adjustment Directive? **Yes** () **No** ()

If so, the Bidder must provide the following information:

- a. name of former public servant;
- b. conditions of the lump sum payment incentive;
- c. date of termination of employment;
- d. amount of lump sum payment;
- e. rate of pay on which lump sum payment is based;
- f. period of lump sum payment including start date, end date and number of weeks;
- g. number and amount (professional fees) of other contracts subject to the restrictions of a work force adjustment program.

For all contracts awarded during the lump sum payment period, the total amount of fees that may be paid to a FPS who received a lump sum payment is \$5,000, including Applicable Taxes.

2.4 Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than seven (7) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

2.5 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Manitoba.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

2.6 Improvement of Requirement During Solicitation Period

Should bidders consider that the specifications or Statement of Work contained in the bid solicitation could be improved technically or technologically, bidders are invited to make suggestions, in writing, to the Contracting Authority named in the bid solicitation. Bidders must clearly outline the suggested improvement as well as the reason for the suggestion. Suggestions that do not restrict the level of competition nor favour a particular bidder will be given consideration provided they are submitted to the Contracting Authority at least seven (7) days before the bid closing date. Canada will have the right to accept or reject any or all suggestions.

PART 3 - BID PREPARATION INSTRUCTIONS

3.1 Bid Preparation Instructions

Canada requests that Bidders provide their bid in separately bound sections as follows:

Section I: Technical Bid (2 hard copies)

Section II: Financial Bid (1 hard copy)

Section III: Certifications (1 hard copy)

Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.

Canada requests that Bidders follow the format instructions described below in the preparation of their bid:

- (a) use 8.5 x 11 inch (216 mm x 279 mm) paper;
- (b) use a numbering system that corresponds to the bid solicitation.

In April 2006, Canada issued a policy directing federal departments and agencies to take the necessary steps to incorporate environmental considerations into the procurement process [Policy on Green Procurement](http://www.tpsgc-pwgsc.gc.ca/ecologisation-greening/achats-procurement/politique-policy-eng.html) (<http://www.tpsgc-pwgsc.gc.ca/ecologisation-greening/achats-procurement/politique-policy-eng.html>). To assist Canada in reaching its objectives, Bidders should:

- 1) use 8.5 x 11 inch (216 mm x 279 mm) paper containing fibre certified as originating from a sustainably-managed forest and containing minimum 30% recycled content; and
- 2) use an environmentally-preferable format including black and white printing instead of colour printing, printing double sided/duplex, using staples or clips instead of cerlox, duotangs or binders.

Section I: Technical Bid

In their technical bid, Bidders should demonstrate their understanding of the requirements contained in the bid solicitation and explain how they will meet these requirements. Bidders should demonstrate their capability and describe their approach in a thorough, concise and clear manner for carrying out the work.

The technical bid should address clearly and in sufficient depth the points that are subject to the evaluation criteria against which the bid will be evaluated. Simply repeating the statement contained in the bid solicitation is not sufficient. In order to facilitate the evaluation of the bid, Canada requests that Bidders address and present topics in the order of the evaluation criteria under the same headings. To avoid duplication, Bidders may refer to different sections of their bids by identifying the specific paragraph and page number where the subject topic has already been addressed.

Section II: Financial Bid

3.1.1 Bidders must submit their financial bid in accordance with the Basis of Payment in Annex B.

3.1.2 Electronic Payment of Invoices – Bid

If you are willing to accept payment of invoices by Electronic Payment Instruments, complete Annex G Electronic Payment Instruments, to identify which ones are accepted.

If Annex G Electronic Payment Instruments is not completed, it will be considered as if Electronic Payment Instruments are not being accepted for payment of invoices.

Acceptance of Electronic Payment Instruments will not be considered as an evaluation criterion.

Section III: Certifications

Bidders must submit the certifications and additional information required under Part 5.

PART 4 - EVALUATION PROCEDURES AND BASIS OF SELECTION

4.1 Evaluation Procedures

- (a) Bids will be assessed in accordance with the entire requirement of the bid solicitation including the technical and financial evaluation criteria.
- (b) An evaluation team composed of representatives of Canada will evaluate the bids.
- (c) Canada will use the Phased Bid Compliance Process described below.

4.1.1 Phased Bid Compliance Process

4.1.1.1 General

a) Canada is conducting the Phased Bid Compliance Process described below for this requirement.

b) Notwithstanding any review by Canada at Phase I or II of the Phased Bid Compliance Process, Bidders are and will remain solely responsible for the accuracy, consistency and completeness of their Bids and Canada does not undertake, by reason of this review, any obligations or responsibility for identifying any or all errors or omissions in Bids or in responses by a Bidder to any communication from Canada.

THE BIDDER ACKNOWLEDGES THAT THE REVIEWS IN PHASE I AND II OF THIS PHASED BID COMPLIANCE PROCESS ARE PRELIMINARY AND DO NOT PRECLUDE A FINDING IN PHASE III THAT THE BID IS NON-RESPONSIVE, EVEN FOR MANDATORY REQUIREMENTS WHICH WERE SUBJECT TO REVIEW IN PHASE I OR II AND NOTWITHSTANDING THAT THE BID HAD BEEN FOUND RESPONSIVE IN SUCH EARLIER PHASE. CANADA MAY DEEM A BID TO BE NON-RESPONSIVE TO A MANDATORY REQUIREMENT AT ANY PHASE. THE BIDDER ALSO ACKNOWLEDGES THAT ITS RESPONSE TO A NOTICE OR A COMPLIANCE ASSESSMENT REPORT (CAR) (EACH DEFINED BELOW) IN PHASE I OR II MAY NOT BE SUCCESSFUL IN RENDERING ITS BID RESPONSIVE TO THE MANDATORY REQUIREMENTS THAT ARE THE SUBJECT OF THE NOTICE OR CAR, AND MAY RENDER ITS BID NON-RESPONSIVE TO OTHER MANDATORY REQUIREMENTS.

c) Without prejudice to its other rights, Canada shall have the right, in its absolute discretion, but shall not be obliged, to request and accept any time, before or after the solicitation closing date, and consider as part of the Bid, any document and materials from Bidders to clarify the Bid or to correct deficiencies or errors in the Bid that are not significant in Canada's absolute discretion, including all matters of form or error in computation or failure to confirm by signing or similarly verifying acceptance. This shall not limit Canada's right to request or accept any information after the bid solicitation closing in circumstances where the bid solicitation expressly provides for this right.

d) The Phased Bid Compliance Process does not limit Canada's rights under Standard Acquisition Clauses and Conditions (SACC) 2003 (2017-04-27) Standard Instructions – Goods or Services – Competitive Requirements nor Canada's right to request or accept any information during the solicitation period or after bid solicitation closing in circumstances where the bid solicitation expressly provides for this right, or in the circumstances described in subsection (c).

e) Canada will send any Notice or the Compliance Assessment Report (CAR) by any method Canada chooses, in its absolute discretion. The Bidder must submit its response by the method stipulated in the Notice or CAR. Responses are deemed to be received by Canada at the date and time they are

delivered to Canada by the method and at the address specified in the Notice or CAR. An email response permitted by the Notice or CAR is deemed received by Canada on the date and time it is received in Canada's email inbox at Canada's email address specified in the Notice or CAR. A Notice or CAR sent by Canada to the Bidder at any address provided by the Bidder in or pursuant to the Bid is deemed received by the Bidder on the date it is sent by Canada. Canada is not responsible for late receipt by Canada of a response, however caused.

4.1.1.2

Phase I: Financial Bid

a) After the closing date and time of this bid solicitation, Canada will examine the Bid to determine whether it includes a Financial Bid and whether any Financial Bid includes all information required by the solicitation. Canada's review in Phase I will be limited to identifying whether any information that is required under the bid solicitation to be included in the Financial Bid is missing from the Financial Bid. This review will not assess whether the Financial Bid meets any standard or is responsive to all solicitation requirements.

b) Canada's review in Phase I will be performed by officials of the Department of Public Works and Government Services.

c) If Canada determines, in its absolute discretion that there is no Financial Bid or that the Financial Bid is missing all of the information required by the bid solicitation to be included in the Financial Bid, then the Bid will be considered non-responsive and will be given no further consideration.

d) For Bids other than those described in c), Canada will send a written notice to the Bidder ("Notice") identifying where the Financial Bid is missing information. A Bidder, whose Financial Bid has been found responsive to the requirements that are reviewed at Phase I, will not receive a Notice. Such Bidders shall not be entitled to submit any additional information in respect of their Financial Bid.

e) The Bidders who have been sent a Notice shall have the time period specified in the Notice (the "Remedy Period") to remedy the matters identified in the Notice by providing to Canada, in writing, additional information or clarification in response to the Notice. Responses received after the end of the Remedy Period will not be considered by Canada, except in circumstances and on terms expressly provided for in the Notice.

f) In its response to the Notice, the Bidder will be entitled to remedy only that part of its Financial Bid which is identified in the Notice. For instance, where the Notice states that a required line item has been left blank, only the missing information may be added to the Financial Bid, except that, in those instances where the addition of such information will necessarily result in a change to other calculations previously submitted in its Financial Bid, (for example, the calculation to determine a total price), such necessary adjustments shall be identified by the Bidder and only these adjustments shall be made. All submitted information must comply with the requirements of this solicitation.

g) Any other changes to the Financial Bid submitted by the Bidder will be considered to be new information and will be disregarded. There will be no change permitted to any other Section of the Bidder's Bid. Information submitted in accordance with the requirements of this solicitation in response to the Notice will replace, in full, **only** that part of the original Financial Bid as is permitted above, and will be used for the remainder of the bid evaluation process.

h) Canada will determine whether the Financial Bid is responsive to the requirements reviewed at Phase I, considering such additional information or clarification as may have been provided by the Bidder in accordance with this Section. If the Financial Bid is not found responsive for the requirements reviewed at Phase I to the satisfaction of Canada, then the Bid shall be considered non-responsive and will receive no further consideration.

i) Only Bids found responsive to the requirements reviewed in Phase I to the satisfaction of Canada, will receive a Phase II review.

4.1.1.3 Phase II: Technical Bid

a) Canada's review at Phase II will be limited to a review of the Technical Bid to identify any instances where the Bidder has failed to meet any Eligible Mandatory Criterion. This review will not assess whether the Technical Bid meets any standard or is responsive to all solicitation requirements. Eligible Mandatory Criteria are all mandatory technical criteria that are identified in this solicitation as being subject to the Phased Bid Compliance Process. Mandatory technical criteria that are not identified in the solicitation as being subject to the Phased Bid Compliance Process, will not be evaluated until Phase III.

b) Canada will send a written notice to the Bidder (Compliance Assessment Report or "CAR") identifying any Eligible Mandatory Criteria that the Bid has failed to meet. A Bidder whose Bid has been found responsive to the requirements that are reviewed at Phase II will receive a CAR that states that its Bid has been found responsive to the requirements reviewed at Phase II. Such Bidder shall not be entitled to submit any response to the CAR.

c) A Bidder shall have the period specified in the CAR (the "Remedy Period") to remedy the failure to meet any Eligible Mandatory Criterion identified in the CAR by providing to Canada in writing additional or different information or clarification in response to the CAR. Responses received after the end of the Remedy Period will not be considered by Canada, except in circumstances and on terms expressly provided for in the CAR.

d) The Bidder's response must address only the Eligible Mandatory Criteria listed in the CAR as not having been achieved, and must include only such information as is necessary to achieve such compliance. Any additional information provided by the Bidder which is not necessary to achieve such compliance will not be considered by Canada, except that, in those instances where such a response to the Eligible Mandatory Criteria specified in the CAR will necessarily result in a consequential change to other parts of the Bid, the Bidder shall identify such additional changes, provided that its response must not include any change to the Financial Bid.

e) The Bidder's response to the CAR should identify in each case the Eligible Mandatory Criterion in the CAR to which it is responding, including identifying in the corresponding section of the original Bid, the wording of the proposed change to that section, and the wording and location in the Bid of any other consequential changes that necessarily result from such change. In respect of any such consequential change, the Bidder must include a rationale explaining why such consequential change is a necessary result of the change proposed to meet the Eligible Mandatory Criterion. It is not up to Canada to revise the Bidder's Bid, and failure of the Bidder to do so in accordance with this subparagraph is at the Bidder's own risk. All submitted information must comply with the requirements of this solicitation.

f) Any changes to the Bid submitted by the Bidder other than as permitted in this solicitation, will be considered to be new information and will be disregarded. Information submitted in accordance with the requirements of this solicitation in response to the CAR will replace, in full, only that part of the original Bid as is permitted in this Section.

g) Additional or different information submitted during Phase II permitted by this section will be considered as included in the Bid, but will be considered by Canada in the evaluation of the Bid at Phase II only for the purpose of determining whether the Bid meets the Eligible Mandatory Criteria. It will not be used at any Phase of the evaluation to increase or decrease any score that the original Bid would achieve without the benefit of such additional or different information. For instance, an Eligible Mandatory Criterion that requires a mandatory minimum number of points to achieve compliance will be assessed at Phase II to determine whether such mandatory minimum score would be achieved with such additional or different information submitted by the Bidder in response to the CAR. If so, the Bid will be considered responsive

in respect of such Eligible Mandatory Criterion, and the additional or different information submitted by the Bidder shall bind the Bidder as part of its Bid, but the Bidder's original score, which was less than the mandatory minimum for such Eligible Mandatory Criterion, will not change, and it will be that original score that is used to calculate any score for the Bid.

h) Canada will determine whether the Bid is responsive for the requirements reviewed at Phase II, considering such additional or different information or clarification as may have been provided by the Bidder in accordance with this Section. If the Bid is not found responsive for the requirements reviewed at Phase II to the satisfaction of Canada, then the Bid shall be considered non-responsive and will receive no further consideration.

i) Only Bids found responsive to the requirements reviewed in Phase II to the satisfaction of Canada, will receive a Phase III evaluation.

4.1.1.4 Phase III: Final Evaluation of the Bid

a) In Phase III, Canada will complete the evaluation of all Bids found responsive to the requirements reviewed at Phase II. Bids will be assessed in accordance with the entire requirement of the bid solicitation including the technical and financial evaluation criteria.

b) A Bid is non-responsive and will receive no further consideration if it does not meet all mandatory evaluation criteria of the solicitation.

4.2 Basis of Selection

4.2.1 Basis of Selection – Highest Combined Rating of Technical Merit and Price

1. To be declared responsive, a bid must:
 - a. comply with all the requirements of the bid solicitation; and
 - b. meet all mandatory criteria; and
 - c. obtain the required minimum of 150 points overall for the technical evaluation criteria which are subject to point rating. The rating is performed on a scale of 200 points.
2. Bids not meeting (a) or (b) or (c) will be declared non-responsive.
3. The selection will be based on the highest responsive combined rating of technical merit and price. The ratio will be 60% for the technical merit and 40% for the price.

4. To establish the technical merit score, the overall technical score for each responsive bid will be determined as follows: total number of points obtained / maximum number of points available multiplied by the ratio of 60%.
5. To establish the pricing score, each responsive bid will be prorated against the lowest evaluated price and the ratio of 40%.
6. For each responsive bid, the technical merit score and the pricing score will be added to determine its combined rating.
7. Neither the responsive bid obtaining the highest technical score nor the one with the lowest evaluated price will necessarily be accepted. The responsive bid with the highest combined rating of technical merit and price will be recommended for award of a contract.

The table below illustrates an example where all three bids are responsive and the selection of the contractor is determined by a 60/40 ratio of technical merit and price, respectively. The total available points equals 200 and the lowest evaluated price is \$45,000 (45).

PART 5 – CERTIFICATIONS AND ADDITIONAL INFORMATION

Bidders must provide the required certifications and additional information to be awarded a contract.

The certifications provided by Bidders to Canada are subject to verification by Canada at all times. Unless specified otherwise, Canada will declare a bid non-responsive, or will declare a contractor in default if any certification made by the Bidder is found to be untrue, whether made knowingly or unknowingly, during the bid evaluation period or during the contract period.

2. The Task Authorization (TA) will contain the details of the activities to be performed. The TA will also include the applicable basis and methods of payment as specified in the Contract.
3. On a monthly basis, the Technical Authority will provide a blanket TA for the estimated cost for performing the task, established in accordance with the Basis of Payment Annex B specified in the Contract.
4. The Contractor must not commence work until a TA authorized by the Technical Authority has been received by the Contractor. The Contractor acknowledges that any work performed before a TA has been received will be done at the Contractor's own risk.

7.1.2.2 Task Authorization Limit

The Technical Authority may authorize individual task authorizations up to a limit of \$ to be determined, Applicable Taxes included, inclusive of any revisions.

Any task authorization to be issued in excess of that limit must be authorized by the Contracting Authority before issuance.

7.1.2.3 Minimum Work Guarantee - All the Work - Task Authorizations

1. In this clause,

"Maximum Contract Value" means the amount specified in the "Limitation of Expenditure" clause set out in the Contract; and

"Minimum Contract Value" means 10% of the Maximum Contract Value.

2. Canada's obligation under the Contract is to request Work in the amount of the Minimum Contract Value or, at Canada's option, to pay the Contractor at the end of the Contract in accordance with paragraph 3. In consideration of such obligation, the Contractor agrees to stand in readiness throughout the Contract period to perform the Work described in the Contract. Canada's maximum liability for work performed under the Contract must not exceed the Maximum Contract Value, unless an increase is authorized in writing by the Contracting Authority.

7.3 Security Requirements

1. The Contractor must, at all times during the performance of the Contract/Standing Offer, hold a valid Designated Organization Screening (DOS), issued by the Canadian Industrial Security Directorate (CISD), Public Works and Government Services Canada (PWGSC).
2. The Contractor personnel requiring access to PROTECTED information, assets or sensitive work site(s) must EACH hold a valid RELIABILITY STATUS, granted or approved by CISD/PWGSC.
3. The Contractor MUST NOT remove any PROTECTED information or assets from the identified work site(s), and the Contractor/Offeror must ensure that its personnel are made aware of and comply with this restriction.
4. Subcontracts which contain security requirements are NOT to be awarded without the prior written permission of CISD/PWGSC.

The Contractor is responsible for deciding if additional insurance coverage is necessary to fulfill its obligation under the Contract and to ensure compliance with any applicable law. Any additional insurance coverage is at the Contractor's expense, and for its own benefit and protection.

The Contractor must forward to the Contracting Authority within ten (10) days after the date of award of the Contract, a Certificate of Insurance evidencing the insurance coverage and confirming that the insurance policy complying with the requirements is in force. For Canadian-based Contractors, coverage must be placed with an Insurer licensed to carry out business in Canada, however, for Foreign-based Contractors, coverage must be placed with an Insurer with an A.M. Best Rating no less than "A-". The Contractor must, if requested by the Contracting Authority, forward to Canada a certified true copy of all applicable insurance policies.

ANNEX A - STATEMENT OF WORK

1. Scope

1.1 Non-Emergency Ground Medical Transportation Services Edmonton, Alberta.

1.2 The requirement is to provide timely and reliable ground transportation services to Referred First Nations and eligible Inuit clients and approved Authorized Escorts from all over Alberta who travel to the Edmonton and surrounding areas for medical treatment. When dispatched by the Health Canada, First Nations and Inuit Health Branch, Alberta Region, Non-Insured Health Benefits Edmonton Referral Unit (referred to herein as FNIHB), this service will pick-up, wait for the client if required, as determined by FNIHB, and drop-off patients from arrival and departure points, including but not limited to accommodations, transportation centres (i.e. bus, airport), medical and/or professional facilities in the defined area of service.

Ground Transportation Services should be based in Edmonton and must be able to travel out to surrounding areas. The requirement is for 24 hours a day, 7 days a week, 365 days per year, ground transportation services, including all labour, transportation, supervision, materials, maintenance, tools and equipment necessary. The principal client groups are Registered First Nations, eligible Inuit and approved Authorized Escorts from Alberta, other provinces and the Yukon who travel to Edmonton and surrounding area for approved medical treatment. Refer to Appendix 1 for areas of coverage. FNIHB may also request trips pick-up/drop-off of medical supplies as required.

1.3 The Contractor is responsible for provision of all vehicles, drivers/resources, and driver dispatch services required.

2. Requirements

2.1 TRANSPORTATION SERVICES:

The Contractor must keep accurate and complete Daily Activity Trip Reports (DATR) of each trips and destination, for the use of the FNIHB Technical Authority. See attached DATR template at Appendix 2 to Annex A.

The Contractor must provide local transportation in the Edmonton area for approved medical treatment and required medical transportation, with the exception of emergency (ambulance), for all clients and approved Authorized Escorts (if applicable) as follows:

- a. Bus depot/airport to hospital or place of accommodation.
- b. Place of accommodation to place of treatment.
- c. Place of treatment to place of accommodation or airport/bus.
- d. Pickup and delivery of medical equipment/medical prescriptions/supplies when clients have received requisitions for supplies/services from the medical professional with the approval of FNIHB (i.e. is along the route of a previously booked trip).
- e. When medical equipment is not returned with a client or approved Authorized Escort, retrieve medical equipment and take to airport for return to home health facility. Additional shipping costs and arrangements are not a part of this contract and will be borne by FNIHB.

The Contractor must be able to transport mobility impaired clients via mobility accessible vehicles. Mobility impairments or special needs may include, wheelchairs, crutches, oxygen, etc. The Contractor

shall be responsible for confirmation of all arrangements. FNIHB is responsible for identifying calls/pick-ups which will require special vehicles/equipment. The Contractor is responsible for safe movement and storage of special equipment while in Contractor care.

The Contractor must ensure that the patient's comfort and needs are met to the best of its ability, taking into account language and cultural considerations.

2.2 TRANSPORTATION SERVICES – DRIVERS, DISPATCH AND VEHICLES

2.2.1 The Contractor's drivers and vehicles must meet the following requirements:

- a. All drivers must have a valid Class 4 Alberta Provincial Drivers licence in accordance with Commercial Driver's Guide to Operation, Safety and Licensing and be able to legally operate a motor vehicle in the province of Alberta.

- b. All vehicles must be in compliance with Alberta Acts and Regulations, including but not limited to Alberta Commercial Vehicle Safety Regulations, and Alberta Vehicle Equipment Regulations 122/2009 Traffic Safety Act (Vehicle Inspection Program) and National Safety Code.

- c. All drivers must possess a valid Cardiopulmonary Resuscitation Training (CPR) certificate.
- d. All vehicles must be clean and mechanically maintained. In the event of breakdown, it must be replaced immediately (within 30 minutes) by another vehicle at the Contractor's expense. The Contractor must contact FNIHB to identify potential delays. Liquidated damages will apply to any assigned trips that cannot be completed by the Contractor.
- e. The Contractor must provide child car seats and/or booster seats as needed. Vehicle anchoring mechanisms employed in this contract must meet or exceed all mandatory Canadian Standards Association (CSA) provincial/federal standards. The Contractor must accommodate rear facing infant car seats brought by clients.
- f. Vehicles and drivers must be identifiable to client/Authorized Escorts and hospitals, etc. and must have Driver and/or Company identification by uniform, and driver identity photo card or equivalent.

2.2.2 The Contractor's drivers and dispatchers:

- a. Must be client-service oriented.
- b. Must have experience working with Indigenous people.
- c. Confidentiality must be observed and upheld.
- d. Report any problems to FNIHB (e.g. with clients, reservations, pick-up, unauthorized Escorts, no shows, etc.) within 30 minutes, or sooner if possible.
- e. Cope with unscheduled trips (e.g. may have a call to pick-up client at short notice).

- f. Have the ability to communicate effectively orally and in writing in the English language.
- g. The Contractor is responsible for all aspects of their drivers' safety and training, including client service, mobility awareness, and measures to ensure drivers can effectively deal with uncooperative or difficult clients.
- h. In accordance with the Non-Insured Health Benefits Program, Medical Transportation Policy Framework, all medical drivers must undergo a screening process. The Contractor is responsible for this process and it must include, but is not limited to an RCMP criminal check, vulnerable sector check and reference check, whereby the general trustworthiness of the driver is assessed. These checks will be conducted bearing in mind that the driver will not only be operating a motor vehicle, but is also entrusted with the transport of medical patients. The drivers will frequently be alone with such persons for extended periods and must be reliable.
- i. The drivers selected by the Contractor must be familiar with the location of hospitals, and their departments, and other medical services within the designated area surrounding Edmonton.
- j. Each driver must be equipped with an appropriate telecommunications device to permit dispatching to occur. The Contractor's dispatch centre must have equipment and staff sufficient to deal with the expected call volume associated with transporting patients to locations all over Edmonton and the surrounding area (as per map).

2.3 TRANSPORTATION SERVICES – TRIP VOLUMES AND LOGISTICS

The volume of trips will vary from month to month.

The Contractor must have access to, and parking permits as required within the designated area any other areas where the need may arise during the existing contract, to facilitate the pick-up and drop-off of clients. FNIHB will make the Contractor aware of any new locations that clients have to travel to in order to attend appointments as they occur.

Daily log forms will be provided by FNIHB identifying the following: Trip Number (provided by the FNIHB Edmonton Referral Unit), trip pick-up time, trip pick-up location, trip drop-off location, trip drop-off time, number of passengers.

Daily Activity Trip Reports (DATR) for each work day must accompany monthly invoices.

The drivers may be requested to remain with patients during appointment time if no other trips are scheduled.

All changes in the number of passengers or the individuals must be approved by FNIHB.

Drivers will only transport clients and Authorized Escorts as approved by FNIHB. All clients and approved Authorized Escorts must show identification at the time of pick-up. However, if the client or Authorized Escort cannot provide identification, FNIHB must be notified.

Contractor is expected to monitor for flight delays and adjust their schedule accordingly. FNIHB will include airlines and flight numbers in the warrants.

Process for Dispatch:

- a. The client contacts FNIHB;
- b. The FNIHB clerk determines client eligibility;
- c. If approved, the FNIHB clerk contacts Contractor to dispatch a vehicle.

Trips and Wait Times:

Each pick up and drop off at a location is considered a trip, regardless as to the length of time it takes to arrive at the pick up or drop off location.

Should a driver arrive at a location and the client is not there, the driver will wait ten (10) minutes. This is considered a trip. If the client is picked up after the wait time has been exceeded, the driver is to request a new dispatch, which is an additional trip.

FNIHB will determine and vary pick up times, as required, in consultation with the Contractor.

It is the Contractor's responsibility to provide their own office space, equipment and trained drivers, including relief or back-up drivers or alternate arrangements (ex. taxi) at Contractor's expense.

Any information gained as a result of this contract is confidential and any breach of confidentiality will be considered a breach of Contract.

At the end of six months, there will be a mandatory meeting held at FNIHB's Edmonton office in Canada Place to discuss and evaluate the services provided and any issues or concerns regarding the contract. The client and Contractor are responsible to coordinate regular meetings to communicate any concerns or issues directly related to the Statement of Work, performance in relation to the Statement of Work and any related issues to this contract. As a minimum, these meetings will occur every six months, or more frequently as required. This will allow for service level improvement to the client.

3. Additional Information

3.2 FNIHB's Obligations

Provide access to FNIHB's Non-Insured Health Benefits Manager, Edmonton Referral, on call supervisor.

Provide timely access to the FNIHB Alberta Region Edmonton Referral Unit staff.

Provide daily log forms that will identify Trip Number, trip pick-up time, trip pick-up location, trip drop-off time, trip drop-off location, and number of passengers

Track the number of daily trips required that were logged by FNIHB immediately prior to the start of the shift.

Provide access to meet with applicable managers at least once every six months, or more frequently if required.

Provide access to monthly trip rate data as recorded by FNIHB.

Provide advice and direction should unauthorized or additional escorts arrive with the client.

Provide advice and direction should a driver feel their safety is at risk when travelling with a client.

3.3 Contractor's Obligations

Unless otherwise specified, the Contractor must use its own resources, vehicles, equipment and software for the performance of this Statement of Work.

The Contractor must provide FNIHB with an up-to date list of all resources, subcontractors, or agents engaged in the Contract who will have access to personal information.

The Contractor must designate a senior individual within its organization to be the point of contact for complying with privacy/security obligations.

The Contractor shall be fully and solely responsible for the actions of its resources, subcontractors, and agents who act on its behalf in the performance of their functions under the Contract.

The Contractor must advise FNIHB and Canada in advance in the event of any change in ownership of all or a part of the Contractor's business.

The Contractor is prohibited from disclosing and/or transferring any personal information outside the boundaries of Canada, or allowing parties outside Canada to have access to it, without the prior written approval of Canada.

The Contractor, at the time of collection of personal information, must be able to notify an individual from whom it collects personal information of the:

- purpose of collection
- requirement to provide the information under the policy governing the provision of Non-Insured Health Benefits;
- any possible consequences of refusing to respond including the delay of service; and
- individual's right of access to and correction of the information; and contact information for the Government of Canada official able to provide the number of personal information banks in which the personal information will be retained.

3.4 Location of Work, Work Site and Delivery Point

The work will occur within Edmonton and surrounding area (refer to Appendix 1) delegated by FNIHB . Pick up and drop off locations may include but are not limited to hospitals, medical clinics, pharmacies, hotels, bus stations, and the airport.

Should the Contractor not have parking permits at these and other locations, they will be required to pay for parking whenever it is required to pick-up/drop-off a client at their own expense.

3.5 Language of Work

All work will be conducted in the English language.
All correspondence will be conducted in the English language.

3.6 Medical Transportation Platform

FNIHB currently uses a FNIHB-owned platform to coordinate medical transportation requirements. Through this system, FNIHB and the Contractor communicate on a daily basis regarding scheduled pickup and drop off locations, dates and times, client names, contact information and addresses, treaty numbers and, reason for trip to assist NIHB and the Contractor in planning and providing timely services.

This platform is a FNIHB-owned web-based, stand-alone system not connected to the government internal network, that can be accessed by any computer with internet access that has the below noted requirements.

FNIHB can change the platform at any point; therefore the Contractor must be able to upgrade/downgrade their systems to be compatible with system requirements of the current and any new platforms. FNIHB will keep the Contractor apprised of any changes.

System requirements for the Current Platform:

Internet Explorer 8+ is required.
Internet Explorer 11+ will need to run in compatibility mode.
ADOBE PDF reader to print warrants and referrals.

Training:

FNIHB will provide up to 40 hours of training within the month before the contract start date. All dispatchers can be trained simultaneously; either at the Contractor's location or at FNIHB's computer lab located at Canada Place, 9700 Jasper Avenue, Edmonton, AB. Details of dates and times will be coordinated between the Technical Authority/Administration Support and the Contractor.

Contractor travel will not be paid should the Contractor travel to Edmonton for this training. FNIHB will pay for any required travel for FNIHB employees going to the Contractor's site.

FNIHB will provide ongoing training and support to the Contractor on the medical transportation platform, as needed.

4. Glossary

"Alberta Region" means the Regional Office of First Nations and Inuit Health Branch.

"Authorized Escort" means any person who has been given the authority by the Edmonton Referral Unit to escort a client to a medical appointment.

"Client" means a recognized Inuit or registered Indian according to the *Indian Act* who is eligible to receive medical transportation benefits under the Non-Insured Health Benefits Program.

"Referred First Nations" are those clients eligible to receive Non-Insured Health Benefits who are referred to the Contractor as requiring medical transportation services.

"Trip" means the pickup or drop-off of a client and approved escort(s) from one location, be it to/from transportation, to/from accommodation, or to/from an appointment to another location. Each leg of travel i.e. from pickup at the airport and drop-off at accommodations, travel to a doctor's appointment, will constitute one "trip."





2. The Commercial General Liability policy must include the following:
 - a. Additional Insured: Canada is added as an additional insured, but only with respect to liability arising out of the Contractor's performance of the Contract. The interest of Canada should read as follows: Canada, as represented by Public Works and Government Services Canada.
 - b. Bodily Injury and Property Damage to third parties arising out of the operations of the Contractor.
 - c. Products and Completed Operations: Coverage for bodily injury or property damage arising out of goods or products manufactured, sold, handled, or distributed by the Contractor and/or arising out of operations that have been completed by the Contractor.
 - d. Personal Injury: While not limited to, the coverage must include Violation of Privacy, Libel and Slander, False Arrest, Detention or Imprisonment and Defamation of Character.
 - e. Cross Liability/Separation of Insureds: Without increasing the limit of liability, the policy must protect all insured parties to the full extent of coverage provided. Further, the policy must apply to each Insured in the same manner and to the same extent as if a separate policy had been issued to each.
 - f. Blanket Contractual Liability: The policy must, on a blanket basis or by specific reference to the Contract, extend to assumed liabilities with respect to contractual provisions.
 - g. Employees and, if applicable, Volunteers must be included as Additional Insured.
 - h. Employers' Liability (or confirmation that all employees are covered by Worker's compensation (WSIB) or similar program)
 - i. Broad Form Property Damage including Completed Operations: Expands the Property Damage coverage to include certain losses that would otherwise be excluded by the standard care, custody or control exclusion found in a standard policy.
 - j. Notice of Cancellation: The Insurer will endeavour to provide the Contracting Authority thirty (30) days written notice of policy cancellation.
 - k. If the policy is written on a claims-made basis, coverage must be in place for a period of at least 12 months after the completion or termination of the Contract.
 - l. Owners' or Contractors' Protective Liability: Covers the damages that the Contractor becomes legally obligated to pay arising out of the operations of a subcontractor.
 - m. Non-Owned Automobile Liability - Coverage for suits against the Contractor resulting from the use of hired or non-owned vehicles.

D.2 Automobile Liability Insurance

1. The Contractor must obtain Automobile Liability Insurance, and maintain it in force throughout the duration of the Contract, in an amount usual for a contract of this nature, but for not less than \$2,000,000 per accident or occurrence.

2. The policy must include the following:

- a. Third Party Liability - \$2,000,000 Minimum Limit per Accident or Occurrence
- b. Accident Benefits - all jurisdictional statutes
- c. Uninsured Motorist Protection
- d. Notice of Cancellation: The Insurer will endeavour to provide the Contracting Authority thirty (30) days written notice of cancellation.
- e. Public Passenger Vehicles - Combined Limits for Passengers and road liability
