This amendment no. 003 has been raised to answer questions received and make changes to the Basis of Payment – Product List as follows:

Questions and Answers:

Q1) Stilton Cheese - Do they require "Stilton" specifically? There is already "blue" cheese on the sheet (Item #1).

A1) Yes, Stilton cheese (item #32 on the Daily list) is required in addition to blue cheese (item #1 on the Dairy list).

Q2) Dairy section (Item, 35, Butter, portion) is this Salted or Unsalted butter

A2) Salted.

Q3) (Miscellaneous Groceries) Item # 370 - Frozen Fries, Country Style. Can they provide more of a description as "country style" usually just refers to regular straight cut fries, however these are already listed on item # 362 and 411.

A3) Item #370 is to be country style hash browns, not fries. Item 362 is a non-coated fry whereas item 411 is a coated fry.

Q4) (Proteins) Line # 52 & 53 Bacon - can we quote on frozen product as this will provide a lower cost base item for the client?

A4) Yes. Fresh or frozen would be acceptable as long as the product has not been frozen more than once.

Q5) (Proteins) Line #57 & 58 Pork Cutlets - Can we quote on a 4oz product as 6oz is unavailable?

A5) Yes.

Q6) (Proteins) Line #62 Ham 1/2 skinned is unavailable is there a substitute?

A6) No.

Q7) (Proteins) Line #116 BOLOGNA SLICED –Is this supposed to be sliced or unsliced?

A7) Unsliced.
