

- **Q3.** Please accept my request for equivalence, the section I am referring to is 09 21 16, Gypsum Board Assemblies. The gypsum board manufacturer I am seeking approval for is Cabot Gypsum, manufactured in Point Tupper, NS.

Subsection 2.2.1 lists CGC, CertainTeed, GP and National Gypsum as the manufacturers of the standard gypsum board, Cabot X Light Core Gypsum would perform as well as the listed products.

Subsection 2.2.2 lists the same companies as above for the approved product manufacturers; Cabot Gypsum's Protec M+M performs the same as the approved products.
