This Solicitation amendment no. 1 is raised to reply to bidders questions.

Question 1

- a) For stream 2: at the time of submission, can you please confirm that all 5 required System Administrator resources are to be unilingual in English?
- b) For Workstream 2, System Administrators, for the five (5) grids that are required to be provided at bid submission time, can you please clarify the language requirement for each. It is understood that language will be identified as required via Task Authorizations, however it is unclear the required language profile for the 5 grids we are submitting.

Answer 1

As 22.7% of the resources in stream 2 are unilingual, the same percentage would apply to the 5 required submissions. So, 4 resources submitted for evaluation must be bilingual and 1 submitted resource must be unilingual.
