This amendment is raised to answer Bidders' questions.

QUESTIONS AND ANSWERS:

Question 6:

We would like to submit a question regarding MTC1 of the Corporate Requirements.

Item 1b) stipulates that the reference contract must have an initial minimum value of \$2,000,000 (CDN) excluding applicable taxes. Most private-sector contracts do not have an minimum value attached at initial issue. Can a private-sector contract which meets all other elements of this requirement and which has had an invoiced, paid value of over \$2,000,000 (CDN) excluding taxes during that period be used? And will a signed letter from the contracting authority for that client attesting to its award date, value, and nature of services provided be acceptable for substantiation purposes?

Answer 6:

Since most contracts do include a value for the initial contract period, a signed letter from the contracting authority will not be accepted to meet MTC 1.b)
