The following changes in the tender documents are effective immediately. This addendum will form part of the contract documents.

This Addendum is raised to provide the following answers to questions provided by bidders.

**Q1**

Page 19, item 5 asks for a rate for inspections on dumbwaiters but notes that it is not in conjunction with the unit rates listed on item 2. Can you clarify what the difference is and why item 2 only asks for rates on 1 dumbwaiter? Does item 5 refer to the 3 other listed dumbwaiters referred to in the tender?

**A1**

The 3 other dumbwaiters will be out of service as the kitchens have been closed and are not used anymore however if they are brought back online then we require to have something in place to inspect them.

**Q2**

Page 10, point 5.1.1 for Integrity Provisions leads to a website to review several pages. After review I believe what is required to be submitted with the bid is a list of our board of directors. This is also referred to in Annex D on page 22. Are these the same and if I submit as Annex D will that suffice?

**A2**

Yes this is the same information. You are asked to submit a list of your board of directors on Annex D, with your bid. If it is not submitted with your bid we can contact you to obtain same within a set timeframe.
