Amendment 01

This amendment is being raised to distribute questions and answers and to make changes to the tender package.

A) QUESTIONS AND ANSWERS

Q1 Is Ice & Water Shield required at leading edge of roof?

A1 No

Q2 Are the contractors supplying the Cedar Ridge Boards and the Rabbeted Pole Ridge Boards?

A2 Yes

Q3 Is a perimeter flashing required on leading edge and gable ends to cover edge of plywood and would this be Copper?

A3 No, there is no flashing at the gable ends. In these areas the new fascia is used to cover the end of the new plywood. Refer to 5/A102 (Architectural Drawings)

Q4 Can you supply a schedule of mock-ups required?

A4 Mock-ups are required for the following:

1. Fascia
2. Hip Cap (bell tower)
3. Wood shingles (can be combined with fascia and hip cap)

Please note, mock ups are not required at bid submission. The awarded contractor is to submit mock ups afterwards.

Q5 Can mock ups be completed and reviewed in the lower mainland?

A5 No. All consultants and the project manager are located in Whitehorse. Mock-ups could be reviewed in Whitehorse if that was preferred, or on the actual building.

Q6 What is the extent of the rafter tail splint replacements, I couldn't find any details as to quantity.

A6 There is only one rafter splint that needs to be completed. Refer to note southwest of the bell tower on drawing 1/A-102 (Architectural Drawings)
