The Request for Proposal (RFP) Amendment 001 is raised to answer questions received from Bidders and amend the RFP accordingly.

QUESTIONS AND ANSWERS

Question: 1

For multi work stream submissions, are Bidders required to submit multiple work streams in a single document or should Bidders submit each individual work stream separately and in accordance with the bid preparation instructions of Section 3.1 for either an epost Connect (a) or hard copy (b) submission.

Answer: 1

Yes, Bidders are requested to submit each individual work stream separately and in accordance with the bid preparation instructions of Section 3.1 for either an epost Connect submission or hard copy submission. See also RFP change no.1 below.

Question: 2

We would like to request a MS WORD version of the RFP for the Professional Services – TBIPS 2 requirement (Solicitation No. EP597-180057/A).

Answer: 2

As stated in the Notice of Proposed Procurement (NPP) for this Requirement, this solicitation document is available in PDF format only.

Question: 3

Corporate rated requirement R2 for Stream 3 (Case Management System Professional Services) states that the Bidder should demonstrate that it is a Microsoft Partner with Competency in CRM (Silver or Gold level). In order to become a Microsoft partner at those levels, companies must have a record of selling a certain volume of product licenses, which cannot be met by most organisations dealing with the Government of Canada, as those licenses are usually acquired directly with Microsoft (by the PSPC ePMO in most cases). We therefore respectfully request that corporate requirement R2 in Stream 3 be removed.

Answer: 3

The point-rated criteria associated with Worksream 3 is intended to assess the Bidder's corporate qualifications related to MS Dynamics; Microsoft Certification is one such measure. The request has been reviewed, the RFP remains unchanged.

Question: 4

Regarding the Corporate mandatory and rated requirements, please confirm that a parent company may use the project references and resources of a subsidiary in order to satisfy the requirements of the RFP.

Answer: 4

The Bidder definition remains unchanged as stated under section 04 of the 2003 (2017-04-27) *Standard Instructions - Goods or Services - Competitive Requirements*: "Bidder" means the person or entity (or, in the case of a joint venture, the persons or entities) submitting a bid to perform a contract for goods, services or both. It does not include the parent, subsidiaries or other affiliates of the Bidder, or its subcontractors.

Question: 5

The financial evaluation is based on "Method 1" which helps to a certain degree to stop unrealistically low rates from being bid. However, with a -20% median being allowed and the fact that the majority of the roles in the streams are value-added roles, a 20% below median range puts one in the lowest quartile for consultant quality. In order to ensure that the Crown receives suitable qualified candidates without necessarily having to resort to full market cost, would the Crown consider reducing the lower side of the median range to -10%?

Answer: 5

The Financial Evaluation remains unchanged.

Question: 6

we respectfully request an extension by one (1) week to the due date to accommodate the level of effort required to provide a complete and concise response to the RFP as well as to make up for the days lost due to the Easter long weekend.

Answer: 6

The closing date for this Solicitation remains unchanged at this time.

Question: 7

In Workstream 5 requirement R-1, each R-1 contract will be scored to a max of 100 points, but the scoring schema provided from R-1.1 to R-1.12 only adds up to 90 points/contract. For example, R-1.1 – R1.4 add up to 90 points, but the Total Max Points states 100. Please confirm each contract is worth 90 points.

Answer: 7

90 points confirmed. See RFP changes no.2 and 3 below.

Question: 8

In relation to the financial evaluation of the bid, can PSPC further elaborate on the how the scoring will be completed? Currently, the pricing schedule requires vendors to only fill out the per diem rate. Will the financial evaluation be based on the total per diem for all categories or will PSPC be providing the level of effort in days to be assigned to each category allowing to a total contract value to be evaluated?

Answer: 8

The Financial Evaluation will be conducted in compliance with section 4.3 Financial Evaluation. Refer to TABLE 2 - EXAMPLE OF A FINANCIAL EVALUATION USING METHOD A (page 26) and TABLE 3 - EXAMPLE OF THE AVERAGE COMPARISON IN METHOD B (page 28) for more details.
