QUESTIONS AND ANSWERS:

Question 2:

Regarding Mandatory Technical Criterion MTC1: Given that many Federal Tier 2 contracts which meet this requirement are awarded with a maximum rather than a minimum value, would the Crown accept a Federal TBIPS contract which meets all requirements in MTC1 but demonstrates its value through a letter from the contract's technical authority confirming that amounts billed and paid under the contract exceed the specified amounts in the specified timelines?

Answer 2:

As long as the initial value of the reference contract is \$2,000,000.00 or more, excluding applicable taxes and amendments, it would meet MTC1 b). A letter from the contract's technical authority is not acceptable to meet MTC1 b).
