QUESTION 3:

Reference: Hook and Loop

Would your client accept A-A-55126C – which is readily available in Coyote 498?

ANSWER:

Canada will accept Hook and Loop in according with A-A-55126C Class 1 in Coyote 498.

QUESTION 4:

To prevent having to submit new samples, will DND accept copies of the new labels that are not on the Samples?

ANSWER:

Refer to Annex D section 9.2. labels will not be evaluated with bid samples.

“9.2 Labels

The Identification and Instruction labels for pre-award samples are not required in the format specified in the TPD (Annexes C-1 and C-2) until after contract award.”

QUESTION 5:

Please confirm shoot packs do not need to be submitted with tender package? They are only required after contract award.

ANSWER:

Please refer to Note 1 on page 2 of the RFP document which states the following:

“Note 1: The requirement for a pre-award sample may be waived if the Bidder has already supplied the pre-award samples for solicitation W8476-165488/A which closed on September 19, 2017. Please refer to the evaluation procedures outlined in Part 4 for further details.”

The decision to submit new ballistic shoot packs for tender W8476-165488/B remains at the discretion of the bidder. Otherwise, the ballistic shoot packs already submitted for W8476-165488/A will be evaluated as part of the bid evaluation for W8476-165488/B.

QUESTION 6:

Bidder designation – Original tender W8476-165488/A. We were bidder “C”. Do we still use this designation?

ANSWER:

No, bidder designation is no longer required. Refer to section 9.1 of Annex D.

All other terms and conditions remain unchanged.
