

SI06 INSUFFICIENT FUNDING

In the event that the lowest compliant bid exceeds the amount of funding allocated for the Work, Canada in its sole discretion may:

- c. negotiate a reduction in the bid price and/or scope of work of not more than 15% with the Bidder submitting the lowest compliant bid. Should an agreement satisfactory to Canada not be reached, Canada shall exercise option (a) or (b).

SI07 BID VALIDITY PERIOD



2. WORKERS COMPENSATION BOARD AND SAFETY PROGRAM

- 2.1. The recommended Tenderer shall provide to the Contracting Authority, prior to Contract Award:
 - 2.1.1. a Workers Compensation Board Premium Rate Statement;



Annex "A" – STATEMENT OF WORK

OBJECTIVE:

Royal Canadian Mounted Police (RCMP) "K" Division requires an entrance walkway repair at the Peace River RCMP Detachment. The existing walkway is deteriorating and is sitting on grade. The objective is to replace the existing entrance walkway with a new entrance walkway which is properly supported with pilings.

BACKGROUND:

The Peace River RCMP detachment was constructed in 2003.

SCOPE OF WORK:

Any concerns found by the contractor during the evaluation, preparation, or installation must be reported to the Project Authority immediately before proceeding with the work to determine if additional measures are required to complete project.

All products and materials are to be installed to the manufacturer's recommendations and specifications.

GENERAL INFORMATION:
