

Amendment 001 is raised to respond to Bidder questions. Questions received after February 27, 2018 may be answered in the next amendment.

Question 1:

Can the Crown please highlight the changes between R000013251/A and R000013251/B? Can the Crown please provide reasons as to why R000013251/A was cancelled?

Response 1:

Canada is re-tendering the solicitation due to not receiving compliant bids for RFP R000013251/A.

The technical requirements are the same as the final Request for Proposal (R000013251/A) after all amendments were made to the initial solicitation through the Question and Answer process. Please refer to R000013251/A, amendments 001 through 006, which are available for download at <u>https://buyandsell.gc.ca/procurement-data/tender-notice/PW-18-00810647</u>.

In addition, Canada modified the minimum pass threshold in section 4.4 Basis of Selection in the new solicitation from a minimum 80% per criterion to 70% overall pass mark.

Question 2:

What is the process if 2 bidders are submitting 2 bids with the same person for one profile, with the rest of the bid and the other profile different? Are they excluded, would they have to show evidence of resource's acceptance or is it a situation accepted by GoC?

Response 2:

Canada will evaluate the proposed resource(s) provided that the Bidder submits all the mandatory technical requirement specified in the RFP. Please refer to <u>3.2 Section 1: Technical Bid, section d), iv) Proposed Professional Services</u> <u>Resources</u> of the RFP for details.

In addition, the Bidder must also meet the certification requirement located in section **5.2** - <u>Certification Required with the</u> <u>Bid, clause (a)</u> - <u>Status and Availability of Resources</u> of the RFP.
