Annex "A" - Scope of Work

OBJECTIVE:

Royal Canadian Mounted Police (RCMP) "K" Division requires roof and wall upgrades at the Chateh RCMP Detachment. A concrete block fire wall that is separating the cell block from the detachment is uninsulated and is causing water condensation to occur. The standing seam metal roofing of this detachment is allowing water infiltration at the roof vents, chimney stack, and fire wall flashing.

BACKGROUND:

The Chateh RCMP detachment was constructed in 1994. A recent cell renovation was completed in 2017-18, but this issue was not addressed.

SCOPE OF WORK:

Any concerns found by the contractor during the evaluation, preparation, or installation must be reported to the Project Authority immediately before proceeding with the work to determine if additional measures are required to complete project.

All products and materials are to be installed to the manufacturer's recommendations and specifications.

- Remove the exterior envelope off the affected cell block wall area and roof area;
- Supply and install waterproofing membrane and Styrofoam insulation to the uninsulated concrete block wall that extends past the existing insulated siding and above the roof area of the detachment.
- Replace any damaged roofing plywood and
- Reinstall the removed exterior envelope, and install new siding on the newly insulated areas to match existing, including the standing seam roof flashing.
- Repair any leaking roof vents, chimney stacks, and fire wall flashing transitions by replacing flashing and seals to specific manufacturer's instructions.
- Complete any mold remediation in the affected area.
- Repair/reinforce the mounting fasteners for the cell block exhaust fans.
- Apply spray foam insulation to the concrete block fire wall within the attic space on the cell block and detachment sides.
- Verify attic insulation and ensure sufficient blanket and blown-in insulation is in place throughout the attic space.
- Repaint affected blocks in cell unit.

GENERAL INFORMATION:

- The Contractor shall provide all materials, labour and equipment necessary to complete the work;
- All measurements are to be confirmed on site by the Contractor;



- All finishes, colours and/or patterns of new and replacement materials are to be approved prior to purchase and/or installation by Asset Management or proxy;
- All specialized work (ie. plumbing, electrical, etc.) shall be completed by a qualified worker;
- All work shall be crafted in a professional manner. No drips, flaws, or second rate work will be accepted. If craftsmanship is lacking, the Contractor shall correct the deficiencies at no additional cost to the Owner;
- All construction waste generated on Site shall be the responsibility of the Contractor, and shall be disposed of properly off site;
- Upon completion of all work, the Contractor shall sufficiently clean the work area including vacuuming with a HEPA filter-fitted vacuum all visible surfaces except the ceiling, followed by wet-wiping; and
- Any changes to the Scope of Work and/or costs must be provided in writing to the Project Authority and must be approved by the Contracting Authority before proceeding.
