**This amendment 001 is raised to answer questions received from industry.**

**Q1:** Is a height adjustable range of 29" – 43" acceptable for item 21 - freestanding height adjustable with full gables and modesty panel?

**A1:** We need all height adjustable tables' range to go down to 27" and up to 41" at the minimum. We have many clients that require their desks to be lower than the standard 29".

**Q2:** Is 18"d acceptable for item 24 – freestanding pedestal? A 22"d will not fit under the desk.

**A2:** We would accept an 18" deep pedestal.

**Q3:** Can we submit a USB Memory stick instead of a CD/DVD?

**A3:** No, we cannot accept a USB memory stick.

**Q4:** Can we use the Garbage/Recycling bins on site for the cardboard etc. from the installation?

**A4:** No, please refer to 6.8 Installation Services.

**Q5:** Can the installation be done after regular business hours as well?

**A5:** Yes, this can be arranged.

**Q6:** The panels have several part numbers that make up the various panels, which will be presented in a separate quote. Please confirm that you require the list of part numbers per panel, as it is quite extensive.

**A6:** Yes, please provide a completed Annex C, Basis of Payment pricing table as well as the extensive list of part numbers to make up the various panels/other items required (as indicated in the instructions to Bidder).

**Q7:** Confirm location of the remaining (23) Hutches apart from the ones shown in Offices 456, 457 & 458. If these are symbols shown next to the Wardrobe in most of the Offices, please confirm where these Hutches will be mounted.

**A7:** These hutches are shown beside the wardrobes in most offices. They will be mounted on existing desks that we are reusing from the current location and they will be at a standard height of 29".

**Q8:** Basis of Payment Item 19 has a count of 24 Laminate Height Adjustable Tables for the Workstations and Basis of Payment Item 20 has a count of 9 Wood Height Adjustable Tables for the Private Offices. Please confirm if Height Adjustable Table in 438 Quiet Room should be included, and if so, should it be Laminate or Wood?

**A8:** I have recounted and it looks like office 450 was missed originally. Item 19 has the correct count, but item 20 should be changed to include office 450, for a count of 10.

**Q9:** Basis of Payment Item 16 has a count of 8 Freestanding Wood Desks (24x72), but 9 desks appear on the floor plan. Please confirm if any of the following offices should not include this desk: 450, 408, 409, 412, 413, 414, 415, 416 & 417.

**A9:** Item 16 should be changed to 9.

**Q10:** Section 5.1.2.1.1: The product we will be proposing is on the Federal Supply Arrangement but is made in the US. Does this disqualify us?

**A10:** This procurement is conditionally limited to Canadian goods. If there are two or more bids with a valid Canadian Content certification, the evaluation process will be limited to the bids with the certification; otherwise, all bids will be evaluated.

**Q11:** We do not have an Aboriginal component, does this eliminate us?

**A11:** This procurement is set aside under the federal government Procurement Strategy for Aboriginal Business (PSAB). Eligible suppliers must meet the certification at 5.1.2.2 Set-aside for Aboriginal Business.

**Q12:** Section 6.4.1: If to be installed by June 1st, will the order be placed by April 12th?

**A12:** We are currently estimating having a contract awarded by mid to late April 2018.
