This amendment is raised to respond to questions received during the solicitation period:

### **QUESTIONS AND ANSWERS**

#### **Question 3:**

One of the mandatory requirements for the Interior Designer is to have “Completed a three (3) or four (4) year program of study resulting in a diploma or degree in Interior Design from a university and/or college recognized by Canada, for example, the Association of Registered Interior Designers of Ontario”.

Could you please confirm that completion of the two (2) year Interior Design program from a technical college in Canada would be sufficient to meet the education requirement given the program meets the standards and guidelines of a 3 year diploma at other colleges?

#### **Answer 3:**

To our knowledge, there is no 2-year Interior Design program that is equal to a 3-year Interior Design program. However, a 2-year program, resulting in a diploma, would be deemed acceptable if the proponent can demonstrate that it is equal to a 3-year diploma from another college. A letter stating such from a reputable institution or association, such as the Association of Registered Interior Designers of Ontario, would be acceptable proof.
