**This amendment is raised to respond to the question received from the industry**

**Question no 1:**

We would like some clarification regarding the “sealed sample” (Tan Colour)) received by DND upon request vs the one available for viewing at the PWGSC office.

We noticed that the sealed samples are not from the “same date” and there is a visual difference between both of them. This has an impact on producing the right color as it is mentioned that the “visual match” will be taking into consideration prior to numerical values measured by the spectrophotometer.

We would like that a clarification be brought to which sealed sample or an average of them will be taken into consideration

**Answer no 1:**

The garment sealed pattern is NOT to be used for colour reference. Potential bidders should use the newest sealed pattern, received directly from DND for visual colour matching.
