**Q1:** *"For Appendix A & B  
Is it standard to utilize the same buses for these shuttles so pick up at Lake Louise overflow, then pick up at Lake Louise Village and then go to Upper Lake Louise? So technically the same 4 buses (and more on long weekends) for these trips?"*

**A1:** Due to the number of visitors most buses run full passenger loads each trip, from each location. For this reason, as well as timing one bus only goes to one stop each trip.
