At ANNEX D – BID EVALUATION CRITERIA, BASIS OF SELECTION, M2:

DELETE: in its entirety

INSERT: M2

The Bidder must have demonstrated Corporate contract experience, in the past 7 years prior to date of RFP issuance involving a transition-in, for a minimum of 3 contracts of a minimum value of \$7 million each.

The referenced 3 contracts 'combined' (not necessarily each contract, but a combination of all 3 contracts together) must address all of the following characteristics:

i) Collaboration with a team of IM/IT resources consisting of at least one of the four resource categories: Application/Software Architects, Programmer/Analysts, Testers and IM Architects service providers.

- (for M2 there are **NO** restrictions of the exact make-up of the team, for example, it could be all Testers, or a combination of 2, 3 or 4 of the resource categories as long as at least one of the four categories makes up the IM/IT team.

ii) The planning, execution and monitoring of Resource Training and/or Knowledge Transfer;

iii) Must have experience with contract transition that can span over many months;

iv) The reporting of transition-in progress; and

v) The resolution of the transition-in

At ANNEX D – BID EVALUATION CRITERIA, BASIS OF SELECTION, R2:

DELETE: in its entirety

INSERT: R2

Points will be awarded for experience over and above that required for M2 as follows:

The Bidder must have demonstrated Corporate contract experience, in the past 7 years prior to date of RFP issuance involving a transition-in, for contracts over and above the minimum of 3 contracts required in M2 of a minimum value of \$7 million each.

To get points for these rated contracts (over and above the 3 required for M2) the Bidders response must address each of the following characteristics.

i) Collaboration with a team of IM/IT resources consisting of at least **two** of the four resource categories: Application/Software Architects, Programmer/Analysts, Testers and IM Architects service providers.

- (for R2 the make-up of the team, could be Testers and Application/Software Architects, or any combination of 2, 3 or 4 of the resource categories as long as at least **two** of the four categories makes up the IM/IT team.

ii) The planning, execution and monitoring of Resource Training and/or Knowledge Transfer;

iii) Must have experience with contract transition that can span over many months;

iv) The reporting of transition-in progress; and

v) The resolution of the transition-in issues

Over and above the three references required for M2 – maximum 10 points

4th contract = 5 points

5th contract or more = 10 points

All other terms and conditions remain the same
