## **REQUEST FOR PROPOSAL AMENDMENT NO. 001**

**Request for Proposal Amendment no. 001 is raised for the following reasons: Questions and answers.**

**Question 1:**

Can the crown clarify if these 18 devices represent a new installation of technology or are they required to replace devices that are currently on-site?

**Answer 1:**

The intention is for the new incoming machines to replace the outgoing, already 'on-site' machines.

**Question 2:**

If some or all of the devices required in the RFP are replacement devices for current installs can the crown confirm the current contract holder?

**Answer 2:**

No, as the contract holders for the outgoing machines do not affect the current solicitation, Canada sees no benefit in listing the current contract holders. It is our intention to award a brand new contract.
