The Request for Proposal (RFP) Amendment 006 is raised to answer Bidders' questions.

Question 21:

In Attachment 4.1,

- a. 3.2.2 Project Executive, - Level 3, Senior Project Leader, **R3**: Would the client accept a PMP Certification as equivalent to the SAP Project Management certification or alternatively award reduced points for a PMP certification?
- b. 4.2. 2 ERP Technical Analyst, SAP BI Specialist, **R8**, Does consolidation of HANA within Business Objects with Universes that contain SQL data count? In other words, does a solution which involves merging HANA tables with an SQL Universe within Webi count? Example: Universes are useful for making database joins between tables.... In many cases, the same can be accomplished using 2 data sources in WEBI (one is an SQL based universe, the other HANA tables). This is done outside of the Data Foundation Layer (and business layer) but done in the transient Universe created by the Webi tool). FYI - The Information Design Tool passes SQL expressions to WEBI (and other tools) but you can have Webi create that SQL and even enhance it manually -if need be - .
- c. 4.2.2 ERP Technical Analyst, SAP BI Specialist **R9**, Can points be awarded if instead of Design Studio the new dashboarding tool 'LUMIRA Designer' was used. SAP is migrating from Design Studio to LUMIRA Designer, which is now in version 2.x
- d. 4.2.4 ERP Programmer/Analyst- Crystal Reports Analyst, **R1**, Would the client accept a BO Certification in place of the Crystal reports certification or alternatively at reduced points.

Answer 21:

- a. No, PMP certification is not accepted as equivalent to the SAP Project Management certification.
- b. Yes.
- c. If a newer product was used (in accordance with SAP's product roadmaps) then it could be considered as a substitute.
- d. No, a BO Certification is not accepted in place of the Crystal Reports certification. R1 remains unchanged for ERP Programmer/Analyst- Crystal Reports Analyst.

Question 22:

An extension has been requested and denied by several firms. This demonstrates not only the need for an extension, but industry's interest in providing the Crown more options for consideration which will result in a higher value. Due to the number of resources required, the current deadline does not allow bidders sufficient time to respond to the requirements with the appropriate level of detail except for the incumbent vendors who already have their resources in place. In order to ensure a fair competition by allowing bidders to fully demonstrate the suitability of their candidates to transition seamlessly into these roles, please consider a short extension of an additional 5-7 business days.

Additionally, the TBIPS Supply Arrangement (SA) states that each Tier 2 bid solicitation will provide qualified Suppliers with twenty calendar days to submit their proposal, which may be extended based on a requirement's complexity. This requirement spans over 4 Workstreams with a total of 14 resources (all but one at the senior level) and also includes Corporate mandatory requirements.
