Q1. Please clarify if all admixtures required for the Grouting Works including Celbex 653 will be paid under the change order process at the actual invoiced material cost plus 10% as per GC 6.4.2 as the answers to questions 8 and 9 in Amendment #2 appear to conflict each other.

A1.: Yes, all admixtures required for the Grouting Works including Celbex 653 will be paid under the change order process at the actual invoiced material cost plus 10% as per GC 6.4.2.

There is no contradiction between answers 8 and 9 as fly ash is not considered a requested additive. There is no specific payment for fly ash and should be accounted for in the other items in the price table.
