ADDENDUM No. 3

The following changes to the tender documents are effective immediately and will form part of the contract documents:

1. GENERAL

1.1	The Bidding Documents are amended as noted in this Addendum, which consists of two (2) pages.
1.2	This Addendum is issued prior to bid closing to incorporate revisions noted herein. Include in the Bid price all such revisions which will become part of the Work. Perform all such Work in accordance with the Contract Documents.
1.3	All affected drawings, schedules and panel changes shall be reflected in final as-built and manual submissions.

2. ANSWERS TO BIDDERS' QUESTIONS

2.1	Question #1: Addendum 001 drawing R.084540.001 included mention of the existing FDS system reinstallation but there is no mention of its required removal prior to fence construction. Answer: Any existing FDS on fences that are being replaced will need to be moved out of the way during construction and re-installed when the new fences are ready. The FDS must remain operational at all times
2.2	Question #2: What is the plan for the FDS sensor for DF1, DF3, DF4 locations; are they to be replaced in their entirety or removed, spliced and re-installed? Answer: Same answer as Question #1 above. No splicing should be required.
2.3	Question #3: If this sensor system is to be removed and reinstalled please identify how may time each sensor cable can be spliced? Answer: Same answer as Question #1 above. No splicing should be required.
2.4	Question #4: please confirm SP2 is not to have FDS removed and reinstalled as well? Answer: The existing FDS will need to be removed from the existing SP2 gate by folding it out of the way if possible, temporarily connecting it to the IPF while construction is occurring and re-installing it on the new SP2 gate once construction is complete. Note that the existing interior perimeter fence FDS must remain operational at all times.
