Amendment 003 has been issued to respond to bidder questions as follows.

Q1. In accordance with the RFP on Security Guard Services, one of the mandatory requirements is to have security licenses in the respective provinces (MB, SK, AB). Are we able to provide proof of these as a condition of contract vs proof at time of proposal submission?

A1. There will be no changes to the Mandatory Technical Criteria. As such, Bidder's must demonstrate that they possess a valid guarding agency license to operate in the provinces of Alberta, Saskatchewan, and Manitoba with their proposal.

Q2. Who is responsible for finger printing the CBSA clients?

A2. Contractors will be responsible for Finger printing - Live scan training will be provided.

Q3. What is your operating hours at the Calgary site?

A3. Schedule of operation - Monday - Friday - 5am - 8 pm (3 shifts per day) Early morning shift are primarily for confirmation of departure.

Q4. Are any of the sites open on Stat holidays?

A4. No, the office is close. Should there be a need for services on a stat holiday, a notice will be sent out to the service provider ahead of time.

Q5. How many guards are required per transport?

A5. Two contracted guards are required per transport.

Q6. Do we need to conduct a personal search ?

A6. Yes, clients need to be searched entering and leaving the sites (pat down etc.). No strip searches are conducted.

Q7. Are there site specific operating procedures?

A7. Yes, Standing operating procedures will be available by contract award

Q8. Are there any Job descriptions for the resources required under this requirement?

A8. Yes, the description's for training, minimum qualification requirements, task etc. are outlined in the SOW

Q9. What is the turnaround time for the Saskatchewan requirement?

A9. The turnaround time is a minimum of 24 hours from notification from the CBSA

A10. No, Saskatchewan does not have a LIVE SCAN machine, therefore finger printing will be conducted manually with ink roller.
