Solicitation Amendment 001 is being issued to respond to questions received on solicitation No. 23440-181318/A

Question 1: The various Survey Instructions refer to attached sketches, but there are no sketches available. Could you arrange to have these make available please?

Response 1: Yes - Please refer to the RFP - Part 2 – Bidder Instructions # 3 – Confidential Information for Bidding, to see on how to obtain those sketches.

Question 2 Would you be able to provide any sample plans for similar type projects please? Either plan numbers or actual plans would be very helpful.

Response 2: A plan prepared for a similar use, but under older Standards, is Plan 103653 CLSR.

Question 3 The RFP states that we can bid on more than one area but that we need a full proposal for each area we bid on. Are we permitted to win more than one area? Also, are we permitted to bid on all 5, and then decline some areas if we happen to win all five?

Response 3: Yes, you can bid on all five. No, you cannot decline some areas if you happen to win all five. Please refer to the terms and conditions within the RFP document.
