The purpose of this amendment is to:

A) RESPOND TO QUESTIONS FROM BIDDERS:

Question 1:

Is it acceptable to alter the size of the booklet specified in *A.2.6 SPECIFICATIONS* to 5 3/8" x 8 1/2" plus bleed instead of 5 1/2" x 8 1/2" plus bleed?

Response 1:

No. Changes to the size of the booklet will not be accepted.

Question 2:

Does this project involve more than printing alone? Or is there editing, design, typesetting involved? And what about distribution?

Response 2:

As specified in the Annex "A" Statement of Work, this is a requirement for the printing, production to final format, and warehousing of 60,000 of *The Little Black Book of Scams*. After the initial delivery by the Contractor, the Contractor must deliver the booklets on skids of 90 boxes (with 75 books per box) to the Project Authority in the National Capital Region (Gatineau) on an "as and when" required basis

There is no requirement for editing, design, typesetting. The print ready files will be provided to the Contractor as a PDF file via email within 24 hours of contract award.
