Solicitation Amendment 006

This Solicitation Amendment is raised to address the following changes.

Revision1:

The closing date of the Solicitation indicated on page 1 of the bid solicitation has been revised. The Solicitation is now set to close on 2018-04-05 at 02:00 PM Pacific Standard Time (PST).

Revision 2:

In Part 1 (General Information), Replace Article 1.2 (Statement of Work) with the following text:

1.2 Statement of Work

Canadian Coast Guard – Department of Fisheries has a requirement for the supply and delivery of three (3), 9.75 – 10.4m, Aluminum Cabin Boats with trailers in accordance with the Statement of Work at Annex A and inspection as per Annex C - Inspection/Quality Assurance /Quality Control.

All the deliverables associated with Boat 1 must be received on or before August 3, 2018.

All the deliverables associated with Boat 2 must be received on or before September 3, 2018.

All the deliverables associated with Boat 3 must be received on or before October 3, 2018.

Revision 3:

In Part 6 (Resulting Contract Clauses),

Replace Article 6.2 (Statement of Work) with the following text:

6.2 Statement of Work

Canadian Coast Guard – Department of Fisheries has a requirement for the supply and delivery of three (3), 9.75 – 10.4m, Aluminum Cabin Boats with trailers in accordance with the Statement of Work at Annex A and inspection as per Annex C - Inspection/Quality Assurance /Quality Control.

All the deliverables associated with Boat 1 must be received on or before August 3, 2018.

All the deliverables associated with Boat 2 must be received on or before September 3, 2018.

All the deliverables associated with Boat 3 must be received on or before October 3, 2018.”.

Revision 4:

In Annex D (Detailed Financial Bid Presentation Sheet),

Replace Article D-4 (Boat Delivery Proposal) with the following text:

D-4 Boat Delivery Proposal

All deliverables are mandatory to be received as per the following schedule;

All the deliverables associated with Boat 1 must be received on or before August 3, 2018.

All the deliverables associated with Boat 2 must be received on or before September 3, 2018.

All the deliverables associated with Boat 3 must be received on or before October 3, 2018.”.

Revision 5:

In Part 6 (Resulting Contract Clauses),

Replace Article 6.6.7 (Method of Payment – Multiple Payment) with the following text:

“6.6.7 Multiple Payments

Canada will pay the Contractor upon completion and delivery in accordance with the payment provisions of the Contract if:

- a. an accurate and complete invoice and any other documents required by the Contract have been submitted in accordance with the invoicing instructions provided in the Contract;
- b. all such documents have been verified by Canada;
- c. the Work delivered has been accepted by Canada.

6.6.7.1 Milestone Payments

1. Canada will make milestone payments in accordance with the Schedule of Milestones detailed in the Contract and the payment provisions of the Contract, up to 100 percent of the amount claimed and approved by Canada if:
 - a. an accurate and complete claim for payment using form [PWGSC-TPSGC 1111](#), Claim for Progress Payment, and any other document required by the Contract have been submitted in accordance with the invoicing instructions provided in the Contract;
 - b. the total amount for all milestone payments paid by Canada does not exceed 80 percent of the total amount to be paid under the Contract;
 - c. all the certificates appearing on form [PWGSC-TPSGC 1111](#) have been signed by the respective authorized representatives;
 - d. all work associated with the milestone and as applicable any deliverable required have been completed and accepted by Canada.
2. The balance of the amount payable will be paid in accordance with the payment provisions of the Contract upon completion and delivery of all work required under the Contract if the Work has been accepted by Canada and a final claim for the payment is submitted.

6.6.7.2 Schedule of Milestones

Note: applies to each boat.

Milestone A – completion of hull and cabin = 30% of Known Work Price for the Boat

Milestone B – completion of outfitting excluding electronics equipment, motors must be operational = 40% of Known Work Price for the Boat

Milestone C – Boat completed and delivered as specified in TSOR = 30% of Known Work Price for the Boat”.
