AMENDMENT 1

Amendment 1 is created to address the following:

Questions from Potential Bidder

1. On drawing 0069330 for the subject RFP, it shows a plastic vinyl handle on the steel latch. This is how the latch is supplied. The coating process called up on the drawing (item 2) involves high heat which will melt this handle. We believe that this plastic handle should be removed prior coating – please confirm.
2. Except for the bottom of the latch base, it is unclear what area(s) of the latch are to have item 2 applied. As we believe that you do not want 3 mils of coating near any of the pivot points as it could lock the latch up do you just want the latch handle coated? Please confirm.

Answers from Technical Authority

1. Confirmed. The plastic vinyl handle is to be removed prior to applying the coating and then reinstalled afterward.
2. The entire latch should be coated, however not necessarily to 3 mils thickness. A minimal thickness of coating is to be applied to the pivot points to ensure that they have corrosion protection, but do not bind (lock) the latch movement.

All other terms and conditions remain the same.
