Amendment 001 is being raised for the following:

1. Provide a response back from Public Works and Government Services Canada to questions received from bidders.
2. Amend Annex B, Basis of Payment, Solicitation B

A. Q1. Is it possible to provide a list of all of the delivery locations for CFB Kingston and the Brockville area?

R1. This requirement is for CFB Kingston, which includes locations in Kingston and in Brockville (Brockville Armoury), Ontario. The estimated number of buildings where delivery may be required for up to 50 different buildings. The actual building number and/or address for delivery will be given on each subsequent call-up as applicable.

B. Q2. Are the estimated usages based on a one (1) year period?

R2. The estimated usages are based on a one (1) year period. The requirement is for three (3) years as per Part 4- Evaluation Procedures and Basis of Selection, 4.1.1.2 Financial Evaluation Criteria:

For Pricing Basis A – Standard Inventory Products: The extended price for each Year will be calculated by multiplying the total Yearly Estimated Usage by the Offeror's corresponding Firm Unit Price per Unit of Issue. The Offeror's Firm Unit Price must contain a maximum of four (4) decimal points/places. The evaluated price for Pricing Basis A is the sum of the extended prices for Year 1, Year 2, and Year 3.

C. Q3. This solicitation includes facial tissue in Pricing Basis A, however other hygienic paper products (hand towels, toilet tissue) are only included in Pricing Basis B. It is most common to see all of these included in the pricing sheet. In order to provide you with the best possible pricing, can these items be included in Pricing Basis A?

R3. The list of items in Pricing Basis A will remain and additional items will not be added at this time.
