SOLICITATION AMENDMENT NO. 003

This amendment 003 is to answer questions related to the RFP

QUESTIONS AND ANSWERS:

Question 008: The M3 Requirement asks for more substantiation than for M1 and M2. We request that a Bidder's response to M3 could exceed the 2-page limitation and remain compliant.

Answer 008: The M3 criteria remains as stated. To clarify, each **contract description** should be no greater than 2 pages in length. The remaining information pertaining to the contract (client, scope, contact information, etc.) are not included in the 2 page limit.

Question 009: Please confirm that the Bidder may use active contracts to substantiate the M3 requirement. In addition, what would comprise proof of a "successful" contract?

Answer 009: Incorrect, M3 remains as stated. Bidders must provide references for two (2) successfully completed contracts.

A "successfully completed" contract is identified as a transaction whereby the client deliverables were fully met in accordance with the expectations of the agreement.
