Question 1:

Would it be acceptable if we use conforming thread and hook and loop tape but substitute colour for the sample? Both items would be matching shell fabric colour for production.

Answer no 1:

Yes, bidders may use conforming thread and hook and loop tape in a substitute colour and long as it is noted in the bid submission that the proper colours will be used for the Pre-Production Sample and Production.

Question 2

Also, YKK don't carry the requested slide fasteners in stock so can we please request a 2 week extension in order to be able to receive their product for sample?

Answer no 2:

2 Week extension not granted. Bidder may substitute the slide fastener as long as it is noted that the supplier will be able to provide the proper slide fastener for the Pre-Production Sample and Production.
