Solicitation Amendment 004 is being issued to respond to questions received on solicitation No. 23440-181318/A

**Question 1:** At the very least obviously the underlying and abutting fabric would be graphically shown. Are we to limit the depiction to being established graphically or is it to be surveyed as posed. I would expand the question to not only include leased lots, but also riparian lots shown on plans deposited in the CLSR within the reserve which are not leased but occupied by members of the First Nations.

**Response 1:** Graphic representation is not sufficient by itself. Each of the interior parcels that will be affected by the Easement must be identifiable on the plan. It is necessary to establish, or possibly re-establish, sufficient lot fabric to enable the accurate locating of the underlying fabric/controlling of the cadastral fabric. It is not necessary to resurvey individual parcel limits.

**Question 2:** Does this project have any anticipated vertical accuracy that we are required to meet?

**Response 2:** The accuracy of any natural limit such as water boundaries or contours must meet the provisions of the National Standards, Chapter 5.

**Question 3:** Are the easement plans to be recorded in the applicable land registry offices after they are recorded in the CLSR?

**Response 3:** No.

**Question 4:** Do the sketches provide the values that we locate for the upper and lower limits of the easements, *or* will these values be provided in the specific survey instructions, *or* do we research and determine both of these values independent of the sketch information?

**Response 4:** The values shown on the sketch are illustrative only. The actual values can be found in the provisional Survey Instructions for each reserve.

**Question 5:** I have been downloading the relevant plans from MyCLSS, and the following Reserves don't show up with the identical designations as in the RFP and Survey Instructions: Area 3: Sabaskong Bay IR35C, Sabaskong Bay 35D, Sabaskong Bay 35F and Sabaskong Bay 35H. Area 4: Northwest Angle 37C.

Could you please get confirmation that the information provided is correct?

**Response 5:** The information provided is correct. Note that Northwest Angle IR #37C is located in Manitoba.
