PART 1 - GENERAL INFORMATION

1.1 Requirement - Bid

2.2 Submission of Bids

Bids must be submitted only to Public Works and Government Services Canada (PWGSC) Bid Receiving Unit by the date, time and place indicated on page 1 of the bid solicitation.

2.2.1 Improvement of Requirement During Solicitation Period

Should bidders consider that the specifications or Statement of Work contained in the bid solicitation could be improved technically or technologically, bidders are invited to make suggestions, in writing, to the Contracting Authority named in the bid solicitation. Bidders must clearly outline the suggested improvement as well as the reason for the suggestion. Suggestions that do not restrict the level of

competition nor favour a particular bidder will be given consideration provided they are submitted to the Contracting Authority at least 3 days before the bid closing date. Canada will have the right to accept or reject any or all suggestions.

2.3 Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than 3 calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

2.4 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in **New Brunswick**.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.

Canada requests that Bidders follow the format instructions described below in the preparation of their bid:

- (a) use 8.5 x 11 inch (216 mm x 279 mm) paper;
- (b) use a numbering system that corresponds to the bid solicitation.

STATEMENT OF REQUIREMENT

Fisheries and Oceans Canada, Gulf region, Crustaceans section, is looking to purchase three bottom trawls and spare parts for those trawls. Specifications of the trawls and type of materials to be used on the trawl plans are found below.

- One trawl, including its footgear, ground wires, bridles and the spare parts is to be shipped and received by July 6th, 2018 to the address mentioned in the offer.
- Two more trawls, including footgear, ground wires, and bridles are to be shipped and received by December 7th, 2018 to the address mentioned in the offer.
- Trawl doors with pennant wires/chains **are not** part of this offer even if indicated on the technical plan.
- Each individual trawl should be packaged and shipped on individual pallet (3 trawls, 3 pallets)
- Wings and bridles should be identified for port and starboard sides.
- Groundwarp (sweep) and bridles should be shipped on a different pallet than the trawls
- Bridles size: bottom ½ inches (13mm), top 3/8 inches (10mm)
- Bridles length: 27.43 meters (90 feet)
- Ground wire length: 27.43 meters (90 feet)
- Ground wire size: ½ inch (13mm)
- Trawl construction: Reinforced netting with 3mm twine on all tapers to be hung on headline, fishing line and wing line
- Bunt bobbin should be 12". Use 2 links of 11mm LL chain on travel wire. Two links should equal a total length/distance of approximately 120mm (60mm per link) between travel wire and fishing line
- Floats information:
 - center section - 4 floats
 - 2.50m section (each side) - 4 floats
 - 6.15m section (each side) – 7 floats

- Single netting along the length of the top, lower wings and wing tips
- 12mm mesh size liner inside the last section (codend) only (49.5 mesh deep section, see trawl plan)
- Liner to extend beyond the cod end by ½ meter with its own draw to close
- Codend length: 5 meters
- There are no extension panels before cod end
- Additional required spare parts (see diagram for spare parts names, location and sizes):
 - 2 upper wings
 - 4 lower wings
 - 2 squares
 - 3 belly#1
 - 3 belly #2
 - 3 codends
 - 3 liners

 Rigging Profile





