## Addendum No. 1

This addendum forms part of the tender documents and modifies them as here-in stated. The following sections of the drawings and specifications have been modified.

### Specifications

**Item 1** Section: 01 14 10 - Security Restrictions, Delete and replace 1.4 Construction Employees with the following:

Security clearances:

- .1 Personnel employed and work on the site must a valid form of identification with picture, i.e. Driver's License or Passport.
- .2 The General Contractor must submit a bi-weekly list of staff names and the names any sub-trades and associated staff that are to be working on site.

Security escort:

- .1 Personnel employed on this project must be escorted at all times when on site.
- .2 Submit an escort request to Departmental Representative at least 7 days before service is needed. For requests submitted within time noted above, costs of security escort will be paid for by Departmental Representative. Cost incurred by late request will be Contractor's responsibility.
3. The costs (minimum 4 hours) incurred by the result of the cancelation of Commissionaire escort with less than 48 notification will be Contractor's responsibility.

**Item 2.** Section 07 52 00 – Modified Bituminous Membrane Roofing, delete and replace 1.4.2 (Quality Assurance) with the following:

Installer to be a member in good standing with the ARCA (Alberta Roofing Contractors Association) or CRCA (Canadian Roofing Contractors Association).

**Item 3.** Section 07 52 00 – Modified Bituminous Membrane Roofing, delete and replace 1.10.4 (Warranty) with the following:

Roofing system has been constructed by a member of the ARCA or CRCA. Contractor shall obtain, on behalf of the Departmental Representative, an ARCA Fifteen Year Warranty Certificate, or Manufacturers 20 Year Warranty Certificate for the performance of Contractor's obligations under the extended warranty.

**Item 4.** Section 07 52 00 – Modified Bituminous Membrane Roofing, delete and Replace 2.9.2 & 2.9.3 (Membrane) Roofing Cap Sheet Membrane for field Surfaces and flashing and Parapets (Thermofusible membrane) with the following:
