Notice is hereby given that the time for reception of tenders previously due at 2:00 p.m. P.D.S.T. on 15 May 2018 is hereby extended to 2:00 p.m. P.D.S.T. on 22 May 2018.

Q1: The Contractor must be responsible to provide and maintain coverage for Products/Completed Operations hazards on its Commercial General Liability insurance policy, for a period of six (6) years beyond the date of the Certificate of Substantial Performance. Does our bonding company have to extend their consent for 6 years?

A1: Contract security is returned following substantial performance, so it does not need to be valid for the 6 years afterwards.

As per GC5.13 (2007-05-25) Return of Security Deposit:

1. After a Certificate of Substantial Performance has been issued, and if the Contractor is not in breach of nor in default under the Contract, Canada shall return to the Contractor all or any part of a Security Deposit that, in the opinion of Canada, is not required for the purposes of the Contract.
2. After a Certificate of Completion has been issued, Canada shall return to the Contractor the remainder of any security deposit unless the Contract stipulates otherwise.
3. If the security deposit was paid into the Consolidated Revenue Fund of Canada, Canada shall pay interest thereon to the Contractor at a rate established pursuant to section 21(2) of the Financial Administration Act (FAA).

All other terms and conditions remain unchanged.
