QUESTION 21

As an electrical subcontractor, are the surface repairs (peat, seeding, paving and / or ...) following electrical trenching work to be paid to the General Contractor's submittal form in Division 32 on page 27 of the specifications : Landscaping 32.1,32.4, 32.24,32.25, ...?

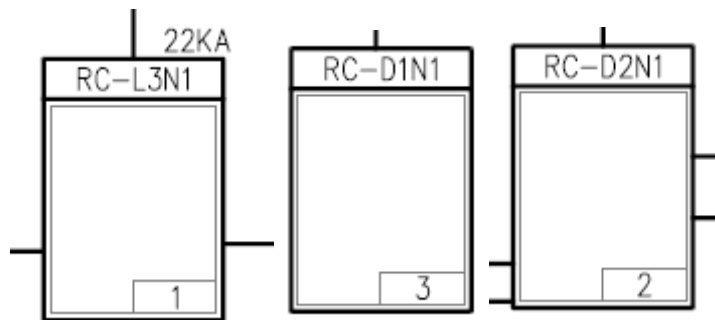
As for the payment method on page 23, items 26.10 and 26.11 indicate the restoration of the premises. However, a new landscaping will be done by the general contractor.

ANSWER 21

Everywhere when new landscape works are specified (and it is mostly the case for all the site) electricity payment item shall not include rehabilitation works. However, electrical connecting at Vinet Street will require rehabilitation of existing sod and concrete sidewalk. Those item shall be included at electrical conduits items.

QUESTION 22

Can we have more details about the panels below (number of circuits, circuit breakers, and / or)?

QUESTION 23

To which detail does the items of the submittal form 26.3 and 26.4 (pull box and junction box) refer to? Is it in section view B of plan E05 / E11, or in section view E06 / E06? Please clarify this point.

ANSWER 23

BPA : These items of the submittal form are for the power of the site, not the warehouse Lapalme. Refer to AECOM documents.

QUESTION 24

For these items, the submittal form indicates 4 for item 26.3 and 1 for item 26.4, however, we see: 1 in plan E01 / E06 for lighting and on plan E03 / E11 for ducts we see 2 junction boxes and 3 draw boxes, please clarify this point.
